#### **CALL TO ORDER**

Chairman Moser called the meeting to order at 10:00 am.

The attendees introduced themselves. Mr. Gogoi announced that a quorum was present.

#### **APPROVAL OF MINUTES**

#### AGENDA ITEM #1 - APPROVAL OF THE April 23, 2013 BPCC MEETING MINUTES

Ms. Huff asked that her name be added to the members who attended the April 23<sup>rd</sup> meeting as her name is missing from the members who did.

MOTION BY MR. DAVIS TO APPROVE THE APRIL 23, 2013 BPCC MEETING MINUTES WITH THE CHANGES TO ADD MS. HUFF'S NAME TO THE LIST OF MEMBERS WHO ATTENDED THE MEETING. SECONDED BY MR. OVERMYER. MOTION CARRIED UNANIMOUSLY.

#### AGENDA ITEM #2 - PUBLIC COMMENTS ON ITEMS ON THE AGENDA

Chairman Moser reported that he had a comment card from Ms. Darla Letourneau and that she would make her comments when the specific items were being discussed.

#### **NEW BUSINESS**

## AGENDA ITEM #3 - APPROVAL OF TAP, MULTI-MODAL ENHANCEMENT, AND SRTS PRIORITIES

Mr. Gogoi presented the staff proposed TAP and Multi-modal priorities and reported that is anticipated that FDOT will program 3 years' worth of projected TA funds which approximately amounts to \$680,000 for each year. The requested amounts of funds totaled over \$5 million. He also reported that there is a sufficient amount of multi-modal box funds to implement all the candidate projects for that category of funding. Ms. Letourneau called for new criteria for TA funds consistent with MAP 21, and called for the committee to reprioritize the staff suggested priorities. Discussion ensued.

MOTION BY MR. JANSEN RECOMMENDING A CHANGE IN THE PRIORITY ORDER SO THAT ABEL CANAL PATHWAY IS PRIORITY **#1, WINKLER AVENUE PATHWAY IS PRIORITY #2, RAY POTTORF** SIDEWALKS IS PRIORITY #3. CONNECTICUT STREET SIDEWALKS IS PRIORITY #4, PELICAN ELEMENTARY SIDEWALKS IS PRIORITY **#5. BONITA SPRINGS ELEMENTARY IS PRIORITY #6. TROPICANA SIDEWALKS** IS PRIORITY PARKWAY **#7**, GATOR SIDEWALKS IS PRIORITY #8, FORT MYERS NEIGHBORHOOD SIDEWALKS IS PRIORITY #9, OLD BURNT STORE ROAD BIKE LANES IS PRIORITY #10 AND RAY ALLEN ELEMENTARY SIDEWALKS IS PRIORITY #11. SECONDED BY MS HUFF. MOTION CARRIED UNANIMOUSLY.

The BPCC concurred with the priority order proposed in Table 1A for the Safe Routes to School projects for the State portion of TA funds and Highways Safety funds.

MOTION BY MR. JANSEN TO RECOMMEND MPO APPROVAL OF MULTI-MODAL ENHANCEMENT BOX FUND PRIORITIES IN TABLE 2 IN THE SAME ORDER AS PROPOSED BY STAFF. SECONDED BY MR. OVERMYER. MOTION CARRIED UNANIMOUSLY.

#### AGENDA ITEM #4 - APPROVAL OF STP AND STATE FUND PRIORITIES

Mr. Scott presented the STP and state fund priorities and explained the various projects on the list. He also highlighted the shared use path project on Bayshore Road. He also discussed the two versions of the proposed priorities. The CAC version called for a removal of the Caloosahatchee River Bridge Incident Management System Phase II project while the TAC version maintained it assigning it however with the lowest priority among all the competing projects. Discussion ensued.

MOTION BY MR. JANSEN TO RECOMMEND MPO APPROVAL OF THE STP AND STATE FUND PRIORITIES CONSISTENT WITH THE CAC VERSION. SECONDED BY MR. OVERMYER. MOTION CARRIED UNANIMOUSLY.

Mr. Scott shared and discussed the comments he had received on the draft Bicycle Pedestrian Safety Action Plan. ## UPDATE ON THE BICYCLE PEDESTRIAN SAFETY ACTION PLAN

**RECOMMENDED ACTION** No action needed. This is a discussion item.

The MPO has now received the comments on the Bicycle Pedestrian Safety Action Plan from each of the Committee's and is working to address the various issues. Staff will report the discussions from the various Committee's and will outline the issues that remain with recommendations on how we should proceed.

## DISCUSSION ON THE DESIGN STANDARDS FOR MARKED AND SIGNED BIKE LANES COUNTYWIDE

**RECOMMENDED ACTION** No action needed. This is a discussion item.

The FDOT's design standards for Bicycle Lanes have changed. For example, the new spacing requirements for pavement marking symbols is ¼ of a mile on roadways with posted speeds less than 45 mph and ½ a mile with speeds of 45 mph or greater. No distinction is made between urban and rural sections. The new standards are referenced in FDOT's current Plans Preparation Manual. The old spacing was 600 ft. in urban sections and ¼ of a mile in rural sections which is the same as recommended in the latest edition of the Florida Green Book. In addition, the new standards do not call for any bike lane signs. The FDOT is now using the new design guidelines in all new construction and 3R projects on state highways in Lee County.

For arterials and collectors owned by the local governments, design standards are implemented using engineering judgment.

At the June 25<sup>th</sup> meeting, there will be a discussion on current design standards practiced in Lee County, and if there is a need for consistent design guidelines across the county on all arterial and collector roadways.

#### LEE COUNTY BICYCLE PEDESTRIAN APP PROPOSAL

**RECOMMENDED ACTION** No action needed. This is an information and discussion item.

Lee County is considering developing a Bicycle/Pedestrian App for smart phones similar to the Calusa Blueway App. Committee member Mike Tisch will report on a proposal that was presented by *Pearl* to Lee County Parks and Recreation and Lee County DOT staff. There are two options for the App - one could be a native iPhone and Android App and the other could be a Mobile Website App, with the costs varying according to the type. The proposal is **attached**.

#### **Project Overview**

Lee County MPO recently developed a printed map which displays accessible biking and pedestrian trails in the area. While the map is very helpful, local cyclist voiced their desire to have a mobile app to access the map and trail information. Because most cyclist, runners and walkers carry a smartphone, it would be ideal for them to utilize a mobile app during a ride or workout rather than carrying a printed map.

#### **Branding**

To begin the process, pearl recommends creating a brand for the trails. Developing a brand for the trails will make them easily identifiable and will create a sense of excitement and brand loyalty among users. Similar to the Calusa Blueway paddling trail and Lee County Waterways, the biking and pedestrian trails would be branded in a similar fashion.

- Name and logo development
- App icon for smartphone home screen
- Incorporate established brand "look and feel" throughout the app

#### **Bike & Pedestrian App**

The bike and pedestrian app will be developed for cyclist, runners, and walkers alike and will utilize google map functionality to overlay trails in Lee County. Users will be able to select the type of map they would like to view and each will cater to that type of exercise. For example, if a family is looking for bike trails, they would select the "family friendly" map which would filter to show only the trails that are suggested for families with children.

Bikers and pedestrians will have the option to choose from different types of maps based on their level of experience or interest (elite, intermediate, novice, mountain biking or family friendly). In addition to the map options, the app will include helpful resources such as traffic laws and signals as well as important phone numbers to have while on the trail.

There are two different types of app options: native smartphone or a mobile website. Although we initially discussed the mobile website app for this project, after further research of functionality and features, pearl recommends developing native smartphone apps for the bike and pedestrian trails. Both options have been outlined below and include pros and cons for each type of app.



#### **Option 1: Native iPhone and Android Apps**

The first option is to develop a native iPhone and Android app. These type of apps are housed directly on smartphones and are not web server reliant, so the user will not experience problems with the app functioning based on internet availability. Users would be able to download the app from the app store or Google Play store. The apps would include all Lee County trails with the ability to drill down to the type desired (elite, intermediate, notice, mountain biking or family friendly).

The most important advantage of native apps is that they are able to run in the background (working whether the phone is active or in sleep mode) and are able to track and store data. This ability allows for an additional section of the app which will track the workout performed by the user as well as track the time, speed and distance of the workout. Users can create a profile to store the data so that they can revisit records of their workout and the path they traveled.

#### Pros

- More reliable GPS services
- Able to run in the background, allowing the workout tracking portion
- Not necessarily web server reliant

#### Cons

- More expensive development cost
- Two separate platforms to develop for

#### **Option 2: Mobile Website App**

The second form is a mobile website app. This type of app relies on a web server and internet connection for use. Because most users will have a wireless connection through their smartphone, they will likely be able to access the mobile site while on the trails. Unfortunately with a mobile website app, the tracking portion will not be possible. Mobile website apps do not run in the background and therefore would not be able to track and store workout data. While creating a mobile website app is a more cost effective solution, it will limit the app to simply showing the maps, current position on a trail and resources.

#### Pros

- Cross platform available on all phones with web browsing capability
- Lower cost of development

#### Cons

- Relies on a web server and internet connection for use
- No background resources, eliminating tracking functionality
- Inconsistent GPS tracking
- App will not have as many features






## Lee County Bike & Pedestrian Native iPhone & Android Apps

# DISCUSSION ON THE MPO NOTIFICATION OF NEW/UPGRADED BIKE PED FACILITIES BY LOCAL GOVERNMENT JURISDICTIONS

**RECOMMENDED ACTION** No action needed. This is a discussion item.

The MPO staff has to monitor and track any new bicycle pedestrian facilities that have been constructed or any existing bicycle pedestrian facilities that have been upgraded so as to be able to update the maps and the total bicycle pedestrian lane mileage countywide (and also by the individual jurisdictions). The tracking of these bike ped projects are confined to arterials and collectors, except when they are on local roads funded with MPO allocated dollars and then we will need to be notified.

We need to track the total mileage by facility types – bike lanes, shoulders, sidewalks etc., and the information will assist us to track the number of new facilities built each year and we will be able to use that information to update the maps and for performance measure reporting.

A process for local governments to notify the completion of projects, along with project details will be discussed at the June 25<sup>th</sup> meeting.
