RECOMMENDED ITEM:


The Bicycle Pedestrian Coordinating Committee is being asked to review, provide input and approve a ten year draft "Cost Feasible" list of Bicycle and Pedestrian improvements that will be included in the Long Range Plan.

The existing Bicycle Pedestrian Master Plan includes a Needs list of Bicycle Pedestrian projects that has been hard to follow and use to implement through the LAP program seeking federal funding for these types of projects. The issues with the current list (**attached** is the screened bicycle pedestrian project list with a separate list of what has been removed to date) include problems with restricted right-of-way, project limits (too long, expensive or not specific enough), drainage issues and/or not good project candidates for federal funding.

Alta Planning and Design and the MPO staff have been reviewing the list to determine project development issues with the goal of identifying a list of candidate projects that are compatible with moving forward for federal funding. The intent is to develop a ten year cost feasible list that will be used during the project application process over the next few years which will then be updated after the upcoming Bicycle Pedestrian Master Plans being developed in the City of Cape Coral and Fort Myers Beach (and any changes to other local plans that occur). The staff is seeking a project list that is in the \$3.5 to \$4.0 million dollar range per year for a total of \$35 to \$40 million over the ten year period, as this is consistent with the amount of federal SU dollars (not including TA, local or TIGER funds) that is projected to be received over the next five years from an analysis of the funding in the Transportation Improvement Program.



Provide an overview on the bicycle and pedestrian lane mile additions from the base year data in 2010 to date.


The MPO has reported the development of bicycle pedestrian lane mile additions over the last few years as a comparison to the 2010 base year that was developed as part of the Master Plan. The analysis of facilities that have been added is also consistent with efforts that were undertaken to establish certain performance measures that are consistent with MAP-21 performance measures. The MPO reporting includes the bicycle and pedestrian facilities that are on functionally classified federal aid roadways which are essentially the Lee County arterials and collectors identified in the state database. The table below includes the bicycle and pedestrian lane mile additions by local jurisdictions as well as the totals and **attached** are the updated facility maps.



PROVIDE INPUT ON THE SCREENING OF THE BICYCLE PEDESTRIAN POLICY RECOMMENDATIONS

RECOMMENDED ITEM: Provide input on the screening of the bicycle pedestrian policy and planning recommendations that are currently included in the MPO's Bicycle Pedestrian Master Plan.

The Bicycle Pedestrian Master Plan that was adopted back in May of 2010 included sixtyfive recommendations that covered policies, planning, coordination and implementation of the Master Plan. Quite a few of the recommendations have been implemented while there are others that have not been addressed at all. As part of the LRTP update, the recommendations are being updated to address what has been completed, what needs to be revised to move recommendations forward that have not been addressed and what needs to be added to bolster the implementation of Master Plan that was developed with the intent of developing a county-wide network of bicycle and pedestrian facilities. **Attached** is the Next Steps Matrix and the Recommendations Status Matrix for review and input.
