REVIEW AND PROVIDE INPUT ON THE TIGER PROJECT PUBLIC INVOLVEMENT PROCESS

RECOMMENDED ACTION:

Provide input on public involvement activities proposed for the LCCSI TIGER project.

Quest Corporation of America will present their approach to providing public information for the TIGER project. Below is an excerpt from the CEI Scope of Services pertaining to public Information services:

(2) Provide Public Information Services and be proactive in keeping the community aware of the status and traffic impacts of the referenced project. With approval from the MPO Project manager, prepare and disseminate information to the public, elected officials and the media of any upcoming events, which will affect traffic flow. Produce and distribute all publications (letters, flyers, brochures and news releases) necessary for this contract. Prior to release, the MPO's designee will approve all responses, letters, news releases and the like. Provide timely, professional responses to project inquiries including emails, telephone calls, etc. Coordinate general public information meetings, open houses, community meetings as directed by the MPO's representatives. Notify Florida 511 of lane closures and detours and notify TeleAtlas of permanent roadway changes. Public Information Services must comply with the MPO's Limited English Proficiency (LEP) Plan by providing reasonable access to project information in languages other than English, as applicable.

Introduction

Currently, the Lee County Metropolitan Planning Organization (MPO) is developing the County's 2040 Long Range Transportation Plan (LRTP). A component of this effort is to build the Existing plus Committed (E+C) network for travel demand forecasting. When coordinating with the Florida Department of Transportation District 1, it was requested that Express Lanes on I-75 be included in the E+C network. Express Lanes are proposed from Dr. Martin Luther King Jr. Boulevard in Lee County to Pine Ridge Road in Collier County.

To support the MPO's ongoing efforts, this draft technical memorandum identifies potential entry/exit points for weave zones on the proposed Express Lanes. This task only investigates the segment in Lee County, from Dr. Martin Luther King Jr. Boulevard to the Collier County Line. It should be noted that the entry/exit points identified are preliminary and for modeling purposes only. Locations of entry/exit points are subject to change during the course of future studies.

Assumptions

The following assumptions were used to determine the entry/exit locations:

- <u>The first assumption</u> is that four Express Lanes two northbound and two southbound — will operate on the inside of the general use lanes on I-75. Lee County's 2035 Needs Plan and the Florida Department of Transportation's (FDOT) 2040 Strategic Intermodal Systems Needs Plan identify four special use lanes as a future need.
- <u>The second assumption</u> is that weave zones will be implemented. The Federal Highway Administration defines weave zones as areas where there is a break in the buffer striping that allows drivers to exit and enter Express Lanes. It is the most widely-used method for accessing Express Lanes in the United States and the least expensive one to implement.
- <u>The third assumption</u> is that I-75 will continue to operate six general purpose lanes, with three in each direction.
- <u>The fourth assumption</u> is that drivers will leave weave zones and cross three general purpose lanes to exit I-75 at an interchange.
- <u>The fifth assumption</u> is that Express Lanes will be built in Collier County, and entry/exit points will be provided in the County. The County's 2035 Needs Plan identifies Express Lanes as a future need.

Methodology

Three sources were used to identify locations for weave zones. First, 2013 Average Annual Daily Traffic (AADT) counts¹ were collected from the Florida Department of Transportation to determine where demand is currently the highest. In addition, the following two highway design books were referenced to ensure that locations are feasible:

- American Association of State Highway and Transportation Officials (AASHTO) *Geometric Design of Highways and Streets* (2004)
- Transportation Research Board (TRB) *Highway Capacity Manual* (2010)

Specifically, AASHTO recommends that weave zones be approximately 2,000 feet long for sufficient entry/exit space. Using the 2010 *Highway Capacity Manual* as guidance, a minimum of 750 feet per lane will be required for crossing general purpose lanes to the highway exit. For developing the 2040 LRTP, this task assumes a conservative estimate of 4,250 feet: 2,000 feet of weave zone and 2,250 feet to cross three general purpose lanes to exit I-75.

Finally, seven interchanges on the proposed Express Lanes segment were identified:

- SR 82/Dr. Martin Luther King Jr. Boulevard
- SR 884/Colonial Boulevard
- SR 876/Daniels Parkway
- Terminal Access Road
- Alico Road
- SR 850/Corkscrew Road
- SR 865/Bonita Beach Road SE

Results

The results displayed in **Table 1** show that Daniels Parkway and Colonial Boulevard have the highest demand. The distance between the two interchanges is 4.6 miles, which would allow for a 2,000-foot weave zone and 2,250 feet for exiting I-75 at an interchange. In addition, there is significant demand at Bonita Beach Boulevard. The distance between Bonita Beach Boulevard and Corkscrew Road is 7.4 miles, which would allow for a 2,000-foot weave zone and 2,250 feet for exiting I-75 at an interchange. The spacing between the Daniels Parkway, Terminal Access Road, and Alico Parkway interchanges does not meet the weaving zone criterion of distance and was eliminated from consideration.

This task assumes that an entry/exit point will be near the start of the Express Lanes at Dr. Martin Luther King Jr. Boulevard. By applying the aforementioned methodology, the following two locations were identified as potential locations for weave zones:

- Between Colonial Boulevard and Daniels Parkway
- Between Corkscrew Road and Bonita Beach Road
