Agenda Item #1 - Call to Order

Agenda Item #4 - *Approval of the June 23, 2020 Meeting Minutes

Mr. Carl Karakos made the motion to approve the June 23, 2020 Meeting Minutes. Mr. Doug Saxton seconded the motion. There were no objections, and the motion passed unanimously.

Agenda Item #3 - Public Comments on Items on the Agenda

There were no public comments on items on the agenda.

Agenda Item #5 - JYLP Trail Extension Design Update

Ms. Adrienne Wisdom with KCA, the consultant for this project, presented this agenda item on the JYLP Trail Extension Design Update. Ms. Wisdom gave a Power Point presentation that included slides with information on the project team, project background, existing trail, project limits, Colonial Boulevard bicycle pedestrian overpass, typical section, project schedule, project coordination, and contact information. The committee briefly discussed the cost for the pedestrian overpass, anticipated location for the crossing at Winkler, pathway, construction date, funding, phases, medians, crossing at Evans, interim solutions, other funding options, possible widening of sidewalk on north side, and coordinating with Lee County staff. Chair Moser thanked Ms. Wisdom for her presentation.

Agenda Item #6 - Review and Input of the Bonita Estero Rail Trail Feasibility Study Scope

Mr. Ron Gogoi presented this agenda item for the review of and input on the Bonita Estero Rail Trail Feasibility Study Scope. He gave a Power Point presentation that included slides with information on project details, funding, schedule, project limits, trail options, cost estimate, scope tasks, and comments and modifications to scope. Mr. Gogoi asked for the committee to send additional comments to him by August 4. 2020. Mr. Gogoi's presentation can be viewed here: https://leempo.com/wpcontent/uploads/Rail-Trail-Scope.pdf. Mr. Gogoi asked if there were any comments from those present. Mr. Doug Saxton suggested adding places of interest, like restaurants and small businesses, to the section that already included parks on page twelve. Mr. Sean Gibbons suggested adding information on connection to existing networks and planning out locations of land trails. Mr. Saxton also mentioned prior success with electronic comments. Mr. Gogoi noted this would be included under public involvement and elaborated on consultant requirements. Mr. Wagley mentioned the success of the public outreach for the Terry Street project prior to the pandemic and suggested reaching out to Mr. Gibbons for information. Mr. Gogoi explained the project team will include staff from the MPO and the local jurisdictions of the Village of Estero and the City of Bonita Springs. Mr. Gogoi also mentioned that there is significant information to cover and details that will be worked out at the first coordination meeting. Chair Moser asked if there were any additional comments. Mr. Gogoi said that Seminole Gulf will be coordinated with and the consultant will continue this coordination. The committee briefly discussed the current situation of the railway. Chair Moser asked if there were any other comments. There were none. Mr. Gibbons thanked Mr. Gogoi and Mr. Scott for their efforts.

Agenda Item #7 - Fort Myers Bike Ped Master Plan Update

Ms. Natalia Lercari with McMahon, the consultant for the City of Fort Myers' Bike Ped Master Plan update, presented this agenda item. Ms. Lercari gave a Power Point presentation that included slides with information on the project team, purpose of the master plan, master plan process, project time line, existing related plans, existing sidewalk facilities map, existing bicycle and multi-modal facilities map, existing transit routes, public engagement process, master plan vision, master plan goals, toolbox for potential future facilities, information on learning more about the plan update, public notice, public survey/questionnaire results, historical crash data map bike/ped, functional classification map, and questions/comments. Mr. Karakos noted that there have been no City Bike Ped meetings due to COVID and that was why the members from tat committee were specially invited to participate in the MPO's Bike Ped committee meeting today. Chair Moser asked if the City's Bike Ped Committee was included on development of the Master Plan update. Mr. Karakos replied yes, one member is on the Project Advisory Committee (PAC) but all members can comment. Brief discussions followed on the virtual Master Plan update meeting held the night before, incorporating electronic access for additional feedback, differences between the 2007 plan process and the update process,

ensuring regular updates to City Council, funding, nature of crashes on Palm Beach corridor, plans for lighting along SR 80 and SR 82, priority criteria and order for projects, process to establish priorities and needs assessment, including planned projects and those under construction, intersection improvements, road crossings, lack of funding to address all needs, safety improvements along Ortiz and Fowler, and an MPO project on Marsh/SR 80. Chair Moser asked if there was additional discussion/feedback. There was none.

Agenda Item #8 - Discussion on the Florida HB 971/SB 1148 Legislation

Chair Moser introduced this agenda item and noted he was working on developing policy language to address this bill. Mr. Don Scott then presented this agenda item as a discussion on the Florida HB 971/SB 1148 Legislation. Mr. Scott said that although he has been reaching out, he has not received responses or recommendations. He briefly reviewed information on the explanation of the bill, impacts on Lee County, liability issues, design implications, and possible solutions. Chair Moser said he had been looking at models from other areas, specifically St. Petersburg. The committee briefly discussed situational remedies, local examples, county restrictions, non-motorized vehicles, establishing speed limits, signage, League of American cyclists website, including all micro-mobility devices, electric bicycles, current status of Fort Myers Beach with respect to regulations, ensuring policies are established and recorded, regulation responsibility for municipalities now that the classification system is established, clarification on law, pedal assist and group riding, and impact on pedestrians. Mr. Gogoi suggested the Walk-On item should be addressed next. Chair Moser agreed.

<u>Agenda Item X – Walk-On Item - Hendry Street Pedestrian Mall Presentation</u>

Mr. Matthew Leger, with the Leger Design Group, presented this agenda item on the Hendry Street Pedestrian Mall concept. He gave a Power Point presentation that included slides with information on his personal background, urban growth, Midtown, pedestrian mall examples, Midtown connection, transport connection, destination connection, additional benefits, mixed-use residential district, low density residential district, vision plan priorities, credits, and questions/input. Chair Moser noted that it would be nice to have a pedestrian only area downtown. Mr. Gibbons commented on the height/density of the proposal, form based code, urbanized dense core area, greenway approach, and light cycle timing. Mr. Leger acknowledged there may be some hurdles and transition options to consider. Mr. Scott mentioned the proposed JYLP extension to Hanson Street and the Caloosahatchee Bridge bike accommodation retrofit. Chair Moser commented on the Canal Street connection alternative to Winkler Canal. Chair Moser asked if there was any public comment.

Agenda Item #9 - FDOT/MPO/Local Agency Updates

Mr. Scott called out the comments in the chat box from Ms. Cindy Leal Brizuela with Lee County Schools and Mr. Patrick Day with DRMP. Mr. Day also verbally commented on the Midtown rezoning for affordable housing and planning for a major pathway for cyclists.

Mr. Gogoi called out the LeeTran chat comment from Mr. Jorge Puente with LeeTran regarding their upcoming virtual public meetings for the Transit Development Plan update.

Agenda Item #10 - Public and Member Comments on Items not on the Agenda

Ms. Marta Gibbons, a member of the public, commented on the pedestrian and bicycle traffic at the intersection of Marsh Avenue and Palm Beach Boulevard.
