Agenda Item #5 - *Approval of the October 26, 2021 Joint Lee and Collier MPO Bike Ped Meeting Minutes

Mr. Gordon Brown made the motion to approve the October 26, 2021 Joint Lee and Collier MPO Bike Ped Meeting Minutes. Ms. Jennifer Hagen seconded the motion. There were no objections, and the motion passed unanimously.

Mr. Gogoi asked to delay Agenda Item #6 due to the presenter, Mr. Brian Raimondo, running late for the meeting.

Agenda Item #9 - Visitor Convention Bureau Presentation

Ms. Simone Behr with the Lee County Visitor & Convention Bureau (VCB) presented this agenda item to highlight the agency's bicycle and pedestrian activities and milestones for the year. Her presentation included information on social media activity, international coverage, website updates, monthly newsletter, influencers used, airport booths, mobile booths, awards, news articles, song writer festival, professional photographer, upcoming events, funding, marketing, and visitor guide update. Her presentation can be viewed here: VCB Presentation The committee discussed using VCB photos for the bike map update, target market, statistical data, marketing during local basketball games, and international staffing.

Agenda Item #6 - *Review and Approve the 4th Edition Countywide Bicycle Facility Map

Mr. Brian Raimondo presented this agenda item for the review and approval of the final version of the 4th Edition Countywide Bicycle Facility Map. The map was attached to the agenda packet, posted to the MPO website, and shown as slides at the meeting. The bike map can be viewed here: https://leempo.com/wp-content/uploads/Agenda-6a.4thEdition-Map.pdf Mr. Raimondo discussed the changes and updates that were made to the facilities portion of the map. He also referred to the bike map layout and commented on the format, items that will be included, and clean up that will be done. The bike map layout can be viewed here: https://leempo.com/wp-content/uploads/Agenda-6b.4th-Edition-Map-Layout.pdf Mr. Raimondo asked for approval for the map, commented on printing quotes. possible addition of updated corrections, and discussed format adjustments to grid lines made during the printing process. Mr. Gogoi commented on the bike facilities under construction on the map. Mr. Raimondo provided additional information on the bike shops that will be included and mentioned transition errors due to laptop conversions. The committee discussed the approval needed, map legend, SR 80 adjustments, previous versions, possible changes to text on layout, state standards for paved shoulders, removing the small shoulder strips on Buckingham, electric bike restrictions, other types of electric mobility devices, next meeting in January due to no meetings in December, digital map availability, Mound Key and Mound House changes, interactive data experience link or contact information, removal of commuter services, regulations regarding earbuds during cycling, format changes, grid lines, publishing, making changes that were listed again by Mr. Raimondo, adding parks to map, adding Estero Bay Preserve, adding bus transfer stations, possibly adding rider requirements for public transportation use, updating LeeTran logos, updating digital version regularly, having separate map layers for sidewalks, QR codes on map to link to website, JRA bike shop relocation, Estero ordinance on electric bicycles, adding notice to check local ordinances, and possibly adding bike ped committees for each of the municipalities.

Mr. Gordon Brown made the motion to approve the 4th Edition Bicycle Pedestrian Map/Flyer. Mr. Henry Burden seconded the motion. There were no objections, and the motion passed unanimously.

<u>Agenda Item #7 - Review and Comment on the Candidate Projects for the 2022 Multimodal TA and SU Fund Priority List</u>

Mr. Ron Gogoi presented this agenda item for the review of and discussion on candidate projects for the 2022 TA and SU funds multimodal priority list. Mr. Gogoi presented slides on the relationship between MPO priorities and FDOT Work Program, new funding cycle, available funding, funding requests from local jurisdictions, and candidate projects for 2022 priorities. The committee discussed proposed sidewalk on US 41 in Bonita Springs, configuration changes and safety concerns at Daniels and Treeline intersection, project process for inclusion in priorities, funding restrictions and requirements, federal process, local agency participation (LAP) certification, criteria/rules, and length of approval for projects. Mr. Don Scott presented this agenda item for the review of and to provide input on the two safety scopes. UPDATE ON THE SR 865 (SAN CARLOS BOULEVARD) PD&E STUDY

PRESENTATION ITEM:

FDOT will provide an update on the San Carlos Project Development & Environment Study (PD&E) from south of Estero Boulevard to Summerlin Road project, ahead of a public meeting scheduled for February 3rd. The PD&E Study is anticipated to be completed by Spring of 2022 and Design in Fall of 2022.

US 41 CALOOSAHATCHEE BRIDGE SIDEWALK UPDATE

INFORMATION ITEM:

The MPO's current FY 2022 through FY 2026 Transportation Improvement Program (TIP) is being amended to add the design phase for adding a sidewalk on the US 41 Caloosahatchee Bridge using American Rescue Plan Act (ARPA) funds in the current year. The amendment was previously not approved by the MPO Board at its November 19th meeting but is now being brought back before the MPO Board, per their direction to staff at the November meeting. The MPO Executive Committee which met on January 12, 2022, approved the amendment. MPO staff will report on the Board action at the January 25th BPCC meeting. Staff will also share a presentation developed by FDOT that covers the benefits of having a sidewalk and latent demand.

OVERVIEW OF THE INFRASTRUCTURE INVESTMENT AND JOBS ACT

INFORMATION ITEM:

On November 15, 2021, the president signed the Infrastructure Investment and Jobs Act (IIJA) also known as Bipartisan Infrastructure Law. This Act also reauthorizes the Federal Transportation Act for five additional years from FY 2022 to FY 2026. Most of this funding is apportioned (distributed) to States based on formulas specified in Federal law. However, the Bipartisan Infrastructure Law also provides funding through a wide range of competitive grant programs. For more information on the bill go to Bipartisan Infrastructure Law - FHWA | Federal Highway Administration (dot.gov).

Staff will provide a presentation at the January 25th BPCC meeting highlighting the bill and anticipated allocations to the state of Florida.

FLORIDA GREENWAYS AND TRAILS UPDATE

DISCUSSION ITEM:

The Office of Florida Greenways and Trails (OGT) is updating the Florida Greenways and Trails System (FGTS) Plan and the Land Trails Opportunity and Priority Maps that accompany this Plan. The Plan is updated every 5 years and the ongoing update will result in a five year plan that will cover the period from FY 2022 through FY 2027.

MPO staff and the BPCC have participated in the two previous updates and our efforts have resulted in identifying the existing Land Trail Opportunity and Priority Trails in Lee County. Paved priority trails in the Plan become part of the FDOT's SUN Trail Network, which then makes them eligible for state SUN Trail funds. The SUN Trail Program has so far brought in \$12.5 million to Lee County.

At the January 25th BPCC meeting, staff will provide an overview of the existing Land Trail Opportunity and Priority Trails in Lee County and initiate a discussion on any changes to existing alignments during the update process. The link to the Land Trails (Opportunity and Priority Maps) is below:

UPDATE ON CANDIDATE PROJECTS FOR THE 2022 MULTIMODAL BOX FUND PRIORITY LIST

DISCUSSION ITEM:

Staff has been coordinating with local governments to identify and submit transit, intersection improvement and bicycle pedestrian projects for the 2022 Multimodal Box Fund Priority List. Staff will present the attached final list of projects at the January 25th BPCC meeting and will be asking the local governments in the membership for an update on the submission process if they have missed the January 24th deadline and will address any issues. Below is a schedule for the project submission process that staff had transmitted electronically to the local governments:

Applications for Lee MPO allocated federal funds are due to MPO staff by **January 24**th (1/24/22). The application development and submission process will follow the following steps:

- MPO staff will review every application for completeness before signing the applications and submitting them electronically to the FDOT MPO liaison. During the review period MPO staff will coordinate with local governments and/or FDOT liaison to resolve any issues identified in the applications.
- MPO staff will submit all applications electronically to FDOT MPO liaison by 2/1/22.
- Changes to applications by project sponsors after February 1st will have to be submitted for MPO staff review and will be accepted until 3/9/22.
- Local governments will be responsible for uploading their sponsored applications in FDOT's Grant Application Process (GAP) after applications have been reviewed and signed by MPO staff by no later than 3/16/22. Documents uploaded in GAP cannot be different from the applications that the MPO staff have signed. They will need to be consistent.
- MPO staff will upload applications for those local governments who do not have a GAP account at the local government request. These applications will be uploaded through MPO's GAP account.
