Meeting Minutes

The meeting was called to order at 3:04 p.m. by Vice-Chair Albert O'Donnell.

Roll Call

The roll was recorded by MPO staff. There was a quorum. Members in attendance included Carie Call, Albert O'Donnell, Marion Briggs, Elaine Sarlo, Justin Thibaut, Steve Henry, Bruce Bohlander (3:20 p.m.), and Randy Krise. Others in attendance included Victoria Peters with FDOT; Cape Coral resident Donald Apking; Cape Coral Police Department Officer; and Lee County MPO staff Don Scott, Ron Gogoi, and Calandra Barraco.

Agenda Item #1 - Public Comments on Items on the Agenda

There were no public comments on items on the agenda.

Agenda Item #2 – LeeTran Report

Mr. Scott provided the LeeTran report that was given by Ms. Dawn Huff with LeeTran at the earlier Technical Advisory Committee (TAC) meeting. The report included updates on LeeTran's Rosa Parks and South Transfer Facilities, existing mobility on demand in Bonita, and upcoming mobility on demand in Lehigh.

Agenda Item #3 – FDOT Report

Ms. Victoria Peters with FDOT provided the FDOT report that included information on mobility week being held October 21-28, 2022. Vice-Chair O'Donnell commented on the expanded definition of mobility and asked what is legal on sidewalks and bike lanes. Ms. Peters said she would research the answer and report back to the committee. The committee briefly discussed the US 41 project, scheduled completion date, backorder of parts, example of other project delays, medians and turning, upcoming Burnt Store public meeting, Burnt Store alternatives, Burnt Store project completion, coordination with Charlotte County, and developer involvement.

New Business

Walk-On Agenda Item – Draft SIS 2050 Cost Feasible Plan

Mr. Don Scott presented this agenda item on the Draft SIS 2050 Cost Feasible Plan. He provided a Power Point presentation that included slides on SIS corridors, SIS connector, estimates development schedule, candidate projects, and MPO coordination/prioritization and survey. The committee discussed survey link, comments, noise walls, Bayshore/I-75 programmed projects, Del Prado interchange, and base year data for 2050 Long Range Transportation Plan.

Agenda Item #4 - *Review and Approval of the June 2, 2022 Meeting Summary

Mr. Randy Krise made the motion to approve the June 2, 2022 Meeting Summary. Mr. Justin Thibaut seconded the motion. There were no objections, and the motion passed unanimously.
Agenda Item #5 - *Review and Approval of the TIP Roll Forward Amendments

Mr. Scott presented this agenda item to amend the Transportation Improvement Program (TIP) to include the Fiscal Year 2022 Roll Forward projects which are inserted at the end of the TIP. These amendments were [posted to the MPO website](#), attached to the packet, and shown as slides at the meeting. Mr. Scott explained the Florida Department of Transportation (FDOT) provides the MPO with a roll forward report that includes projects in the previous state fiscal year that were not started, have uncommitted portions of projects that have started, or have funds remaining on completed projects. He added these projects automatically roll forward in FDOT's Work Program but need to be accounted for in the MPO's new TIP. He noted this amendment is being done to account for these projects in the FY 2023 through FY 2027 TIP. He reviewed several projects in the roll forward report. The committee briefly discussed the accounting for the leftover amounts and the Caloosahatchee Bridge sidewalk project.

Ms. Marion Briggs made the motion to approve the TIP Roll Forward Amendments. Ms. Carie Call seconded the motion. There were no objections, and the motion passed unanimously.

Agenda Item #6 - *Review and Provide Input on the CAC Resolution Recommending the Implementation of an Increased Electric/Hybrid Vehicle Registration Fee

Mr. Scott presented this agenda item for the review of and input on a resolution recommending the implementation of an increased registration fee for electric and hybrid vehicles. The Citizen Advisory Committee resolution and the breakdown of fees by state were [posted to the MPO website](#), attached to the packet, and shown as slides at the meeting. Mr. Scott provided a Power Point presentation that included slides with information on fuel consumption, average fuel efficiency, electric vehicle (EV) impacts on market share, EV impacts to transportation revenue, percentage of EV sales, other state EV fee examples, Florida driver averages, and Citizen Advisory Committee (CAC) resolution. Mr. Scott said staff was seeking recommendations on this agenda item. His presentation can be viewed here: [EV Presentation](#) Mr. Ron Gogoi then provided additional slides with information on registration fees, breakdown of EV versus rest of vehicles, EV and hybrids, and EV ranking. Mr. Gogoi's slides can be viewed here: [Additional EV Presentation](#) The committee discussed the Technical Advisory Committee (TAC) comment on not specifying an amount, wear and tear of a heavily loaded truck, not being highest fee amount in country, attempt to match gas vehicle fees paid into tax, political pushback if higher than other states, changing resolution wording from a specific amount to sufficient to offset loss of revenue, ensuring that amount is equal to fuel tax paid by an average gasoline car, choosing CAC member to present item to MPO Board, volunteering Vice-Chair O'Donnell to present to the MPO Board, providing link to data for average gas tax paid, providing background, incentives to purchase EVs, history of gas tax, example of income tax, user based tax, increasing gas tax, and providing revised resolution for next meeting.

Agenda Item #7 - Provide Input on Upcoming LRTP Amendments

Mr. Scott presented this agenda item for input on upcoming LRTP Amendments. He explained MPO staff has begun working on proposed amendments to the 2045 LRTP that will be voted on later this fall and these amendments will include changes to the tables to address some of the guidance that was provided by FHWA and FDOT on better illustrating the comparison of project costs and revenues by funding source. The FDOT guidance information was attached to the agenda packet and [posted to the MPO website](#). Mr. Scott provided a Power Point presentation that included slides with information on FHWA comments, fund table, table example from Tallahassee, Kingston project and need for

Corkscrew amendment, map of Kingston project area, and 2045 LRTP map. His presentation can be viewed here: [LRTP Presentation](#) The committee discussed money contributed from developers in past for Corkscrew area, impact fees, different categories for each piece of land developed, increasing four lanes on Corkscrew to six, and providing additional information at future meetings.

Agenda Item #8 - Provide Input on Joint Meeting Discussions and Agenda Items with the Collier MPO

Mr. Scott presented this agenda item for input on joint meeting discussions and agenda items with the Collier MPO. He said the Lee and Collier MPO's are in the process of planning for joint TAC, CAC and MPO committee meetings this fall. He mentioned the Joint TAC and CAC meetings might be held at the end of October or beginning of November, possibly at the FDOT SWIFT Center as the CAC has requested an upcoming meeting be held there. He said staff is seeking input on potential agenda items for the upcoming joint meetings with the following agenda items suggested thus far for consideration: Review and Approve the updated Joint Coordination Agreement, Status Report on the I-75 Feasibility Study, and Update on Regional Roadway Projects Crossing/Vicinity of the County Line. He asked if there were additional suggestions. There were none.

Agenda Item #9 - Overview of Crash Data Year to Date

Mr. Scott presented this agenda item as an overview of the crash data year to date. He provided a Power Point presentation that included slides with information on crash dashboard, CTST crash data through June, June crashes by type, and Dangerous by Design report. His presentation can be viewed here: [Crash Data Presentation](#) The committee discussed continual trend toward more crashes each year, Florida's past rankings, overall national trend toward increased crashes, factors unique to Florida, only using permanent population in Florida and not factoring in visitors, use of urbanized area population instead of total population in Lee County, inability to figure out what data was used in Dangerous by Design report, inability to match statistics in report, number of crashes in Florida attributable to out-of-state drivers, minority factors, police reports not including ethnicity, Florida being highest in country for unlicensed drivers, examples of local crashes in parking lots, crash dashboard data, history of when our area placed first on Dangerous by Design report, how data was calculated then with consideration of how many walked to work, not taking into consideration wheelchairs or cyclists, new vehicle technology, and possible influence new technology will have on frequency and types of future crashes.

ENDORSEMENT OF THE AVIATION PRIORITIES

RECOMMENDED ACTION: Recommend that the MPO endorse the Lee County Port Authority's priorities for aviation projects at the Southwest Florida International Airport and the Page Field Airport.

The Lee County Port Authority is currently working on its latest priorities for aviation projects at Southwest Florida International Airport and Page Field for endorsement by the MPO. Since air carrier and general aviation airports are eligible for funding from different sources, projects are prioritized by the Lee County Port Authority separately for each airport. The individual priority list will be emailed out to the TAC and CAC by Monday, August 29th.

**REVISE THE FEDERAL AND STATE PRIORITY LIST TO
INCLUDE THE CAPE CORAL BRIDGE PROJECT**

RECOMMENDED ACTION: Review and approve the revised Federal and State priority list (**attached**) to include the Cape Coral Bridge project.

The Lee County DOT is conducting a PD&E study as part of the project development process to replace the older westbound span of the Cape Coral Bridge along with increasing the bridge capacity to six lanes. The project team for the Cape Coral Bridge project needs an FDOT work program item number for FDOT to become the lead federal agency for the project. FDOT has asked that this request come from the MPO and as such we are adding it to the MPO priorities to help move the project forward. The current funding for the project is coming from Lee County funds, but this project will be developed following the federal requirements which will make the project eligible for federal discretionary funding that might be available when it is constructed.

REVIEW AND APPROVE THE CARBON REDUCTION PROGRAM PRIORITIES

RECOMMENDED ACTION: Review and approve the **attached** recommended Carbon Reduction Program fund priorities.

The Bipartisan Infrastructure Law (BIL) established the Carbon Reduction Program (CRP) which provides funds for projects designed to reduce transportation emissions, defined as CO₂ emissions from on-road highway sources. A portion of the total funds apportioned to a state are suballocated to urbanized areas with populations greater than 200,000 and urbanized areas with population 50,000 to 200,000.

For FY 2022, the suballocation of CRP funds for the Cape Coral urbanized area is \$1,128,685. The FY 2022 funds will most likely be available for programming projects in FY 2024, the first year of FDOT's new Work Program for the period covering FY 2024 through FY 2028. Funds may be also available for programming projects in the subsequent years of this work program which is currently under development.

Eligible projects for CRP funds include bicycle pedestrian facilities, micromobility, public transportation, congestion management technologies, etc. and they must be identified in an MPO's Transportation Plan. That makes most of the bicycle pedestrian projects in the Lee MPO's Adopted Multimodal Box Fund Priorities eligible for CRP funds. The recommended priorities are shown in **Attachment A**. Priorities have been assigned consistent with their priority order from the adopted Multimodal Box Fund Priority list.

To meet FDOT requirements, in the interim, for consideration of Carbon Reduction Program funds in FY 2023 of the Adopted Work Program, and/or in the Tentative Work Program for FY 2024 through FY 2028, the above Carbon Reduction Program eligible projects in the CRP Priority list are identified by reference to the Bike Ped Element of the 2045 Transportation Plan. These projects are specifically identified in Table 1-2: 2045 Bicycle Pedestrian Needs Plan and Table 1-4: 2045 Bicycle Pedestrian Cost Feasible Plan Projects.

For long term consistency requirements, the Lee MPO will amend its 2045 Transportation Plan to add a special chapter on the Carbon Reduction Program that will include a list of candidate projects for Lee MPO CRP fund priorities. All such priorities will be considered by FDOT for inclusion in the Tentative Work Programs.

**REVIEW AND APPROVE THE REVISED RESOLUTION
RECOMMENDING THE IMPLEMENTATION OF AN INCREASED
ELECTRIC/HYBRID VEHICLE REGISTRATION FEE**

RECOMMENDED ACTION: Review and approve the revised resolution recommending the implementation of an increased registration fee for electric and hybrid vehicles.

At the August meeting, the CAC approved moving forward on making a recommendation to the MPO Board to legislatively work on implementing an increased registration fee for electric and hybrid vehicles. The input at the last meeting included removing specific amounts for the registration fee and tying it back to the average paid by gasoline vehicles. The revised resolution is **attached** for the committee's consideration.

RESOLUTION 22-01

A RESOLUTION OF THE LEE COUNTY METROPOLITAN PLANNING ORGANIZATION CITIZENS ADVISORY COMMITTEE RECOMMENDING THAT THE MPO BOARD SUPPORT LEGISLATION THAT WOULD ENACT AN INCREASE IN THE ELECTRIC AND HYBRID VEHICLE REGISTRATION FEES IN FLORIDA

Whereas, most of the funding for road maintenance and construction is collected from fuel taxes;

Whereas, there are now thirty states that have implemented an increased registration fee for electric and/or hybrid vehicles to offset the issue that electric vehicles do not pay fuel taxes that fund the transportation system;

Whereas, within five to ten years, the fuel taxes that Florida collects will level off and then start declining due to increased electric and hybrid vehicle usage along with more fuel efficient vehicles in the fleet;

Whereas, as Florida's population and vehicle miles travel is still projected to grow causing increased transportation impacts and needs while transportation funding decreases over time;

Whereas, electric vehicles are heavier and provide more wear and tear on the roadways but these vehicles currently do not contribute their equitable amount of funding to the transportation trust fund;

Whereas, the implementation of an electric vehicle registration fee and a hybrid vehicle registration in Florida will provide an equitable collection of transportation maintenance and construction funding.

NOW THEREFORE, BE IT RESOLVED that the MPO's Citizen Advisory Committee recommends the MPO Board support the implementation of an electric vehicle and hybrid vehicle registration fee sufficient to offset the loss of revenue equal to the fuel tax paid by the average driver in Florida to improve transportation user funding equity and to help restore the projected short and long term funding loss to the transportation trust fund.

UPDATE ON THE FEDERAL DISCRETIONARY AND FORMULA GRANT PROGRAMS

DISCUSSION ITEM:

FDOT has provided dates for the upcoming regional grant information sessions around the state and the dates/times are **attached**. Listed below is a short status outline on some of the current grant programs:

- **RAISE** – The 2022 grant announcements were recently announced with 166 total projects being funded around the nation and five projects funded in Florida. The five projects in Florida include a Multimodal Transit Center in Clearwater, a new berth in Port of Tampa, a cargo optimization and resiliency project in Port of Miami, a corridor trespassing and intrusion mitigation project for the East Coast Rail project and a SMART project in St Augustine.
- **Safe Streets for All Grant Program** – The deadline for submittal is September 15, 2022 and funding can be used to develop or update a comprehensive safety action plan (Action Plan), conduct planning, design, and development activities in support of an Action Plan and to carry out projects and strategies identified in an Action Plan.
- **Reconnecting Communities Grant Program** – The deadline for submittal is October and funding can be used for planning and construction activities that includes:
 - Planning studies of current traffic patterns on the eligible facility proposed for removal, retrofit, or mitigation and the surrounding street network; transportation network capacity; alternative roadway designs or other uses for the right-of-way; impacts to the mobility of freight and people; impacts to the safety of the traveling public; cost; anticipated economic impacts and environmental impacts both human and natural.

Public engagement activities to provide the public opportunities to provide input into a plan to remove and convert an eligible facility. Other transportation planning activities required in advance of a project to remove, retrofit, or mitigate an existing eligible facility to restore community connectivity, as determined by DOT.

- Removal, retrofit, or mitigation of an existing eligible facility. Replacement of an eligible facility with a new facility that

restores community connectivity and is sensitive to the context of the surrounding community.

Preliminary and detailed design activities and associated environmental studies; predevelopment / preconstruction; permitting activities including the completion of the National Environmental Policy Act (NEPA) process; delivering community benefits and the mitigation of impacts identified through the NEPA process or other planning and project development for the capital construction project.

- **National Electric Vehicle Infrastructure Program** – Provide electric vehicle charging infrastructure and operating expenses. To date, the program has only been addressing the formula funds. As required, FDOT submitted a charging investment plan that added new alternative fuel routes over the original focus that included charging along the interstates around the state. The current plan that FDOT submitted adds in the US 41 and SR 80 corridors in Lee County. Approval of the plan by USDOT is required before they can move forward with the formula funds to Florida and that is expected to occur by the end of September.

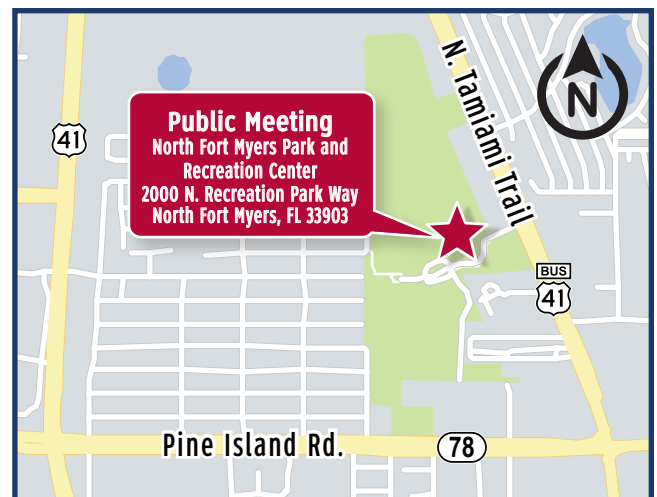
