### **Meeting Minutes**

The meeting was called to order at 3:01 p.m. by Chair Rick Anglickis. The Pledge of Allegiance was recited.

#### Roll Call

The roll was recorded by MPO staff. There was a quorum. Members in attendance included Carie Call (3:12 p.m.), Rick Anglickis, Bev Larson, Don Apking, Kevin Berry, Steve Henry, Jessica Russo, and Randy Krise. Others in attendance included Victoria Peters and Steven Andrews with FDOT; Cape Coral Police Department Officer; Kristin Caruso and Jay Winter with Scalar; and Lee County MPO staff Don Scott, Ron Gogoi, and Calandra Barraco.

#### Agenda Item #1 - Public Comments on Items on the Agenda

There were no public comments on items on the agenda.

#### Agenda Item #2 – LeeTran Report

Mr. Don Scott provided the LeeTran report given by Ms. Dawn Huff with LeeTran at the earlier Technical Advisory Committee (TAC) meeting. He reviewed the report items including November changes to begin seasonal service, Sanibel service, Rosa Parks completion, ninety percent completion of plans for Lehigh center, South center construction, and ADA Assessment Plan update.

#### Agenda Item #3 – FDOT Report

Ms. Victoria Peters with FDOT provided the FDOT report that included information on rescheduling of discretionary grant workshops due to Hurricane Ian, draft work program updates, and work program public involvement outreach. The committee discussed the recent FDOT closure of the Caloosahatchee bridge.

#### **New Business**

#### Agenda Item #4 - \*Review and Approval of the September 1, 2022 Meeting Summary

Ms. Bev Larson made the motion to approve the September 1, 2022 Meeting Summary. Mr. Steve Henry seconded the motion. There were no objections, and the motion passed unanimously.

#### Agenda Item #5 - \*Recommend MPO Adoption of the 2022 Highway Safety Targets

Mr. Don Scott presented this agenda item to recommend MPO Adoption of the 2022 Highway Safety Targets. He noted that every year the MPO is required to adopt the Highway Safety Performance Targets. He added FDOT has been maintaining 'zero' for the target for the five (5) Highway Safety Performance Measures since the statewide targets were first established in 2018. He said the Lee MPO continues to support the Florida statewide targets and referred to the safety performance measures reporting by MPO area and the safety targets that staff recommended for 2023 to be

consistent with the FDOT safety targets which were attached to the meeting agenda packet, <u>posted to the MPO website</u>, and shown as slides at the meeting. The committee discussed the recent trends for fatalities and serious injuries.

Mr. Randy Krise made the motion to recommend MPO Adoption of the 2022 Highway Safety Targets. Ms. Jessica Russo seconded the motion. There were no objections, and the motion passed unanimously.

#### Agenda Item #6 - \*Review and Approve the TIGER Project Data Collection Scope of Services

Mr. Scott presented this agenda item for the review and approval of the TIGER Project Data Collection Scope of Services. He said the MPO is required to collect performance measure data for the next two years as part of the performance data collection and reporting requirements that came with the TIGER grant requirements back when it was awarded in 2013. He explained the baseline data was collected in 2015, just prior to construction starting. He continued the first year of performance data, after construction completion, was collected last in 2019 in mid-December based on the date of project completion. He added the collection of bicycle pedestrian counts, crash data analysis and transit ridership are required to be collected each year whereas the survey data collection is required to be collected in 2021 and 2023, this was also collected for the baseline prior to construction. He referred to the draft scope for this year's data collection, which was attached to the agenda packet, posted to the MPO website, and shown as slides at the meeting. He also mentioned the locations identified to collect the counts are illustrated on the exhibits and are consistent with the data locations done in the past. The committee discussed the purpose of the counts, number of counts stations, and locations of count stations.

Ms. Bev Larson made the motion to approve the TIGER Project Data Collection Scope of Services. Ms. Jessica Russo seconded the motion. There were no objections, and the motion passed unanimously.

#### Walk-on Agenda Item – Recommend 2022 SUN Trail Priorities

Mr. Ron Gogoi presented this walk-on agenda item to recommend MPO Board approval of the 2022 Sun Trail priorities. He provided a brief Power Point presentation that included slides with information on the SUN Trail priority list, Kismet Parkway project, Estero Boulevard project, and the Caloosahatchee Downtown Multimodal Alternative Study project. The committee briefly discussed the funding amounts, local match, and discussion at the Technical Advisory Committee meeting. Mr. Gogoi's presentation can be accessed here: 2022 SUN Trail Priorities

Ms. Bev Larson made the motion to recommend MPO Board approval of the 2022 SUN Trail Priorities. Mr. Steve Henry and Ms. Carie Call seconded the motion simultaneously. There were no objections, and the motion passed unanimously.

#### Agenda Item #7 - Burnt Store Road Project Development & Environment Study Presentation

Mr. Steven Andrews with FDOT introduced himself and Ms. Victoria Peters, also with FDOT. He then introduced Ms. Kristin Caruso and Mr. Jay Winter with Scalar, FDOT's consultant for this project, to present this agenda item. Ms. Caruso then presented this agenda item on the Burnt Store Road Project Development & Environment Study. Ms. Caruso provided a Power Point presentation that included slides with information on project description, project background, main design considerations, project alternatives, evaluation matrix, public involvement, project timeline, transportation project development process, action items, and FDOT contact information. Store Road, access to Vincent Avenue by Burnt Store Marina residents, access management plan based on Lee County regulations, traffic signals on Burnt Store Road, additional development in area, future plans for road connections to Tucker's Grade, traffic in Punta Gorda area near Burnt Store Road, Pine Island sidewalk project, public involvement and comments submitted regarding Burnt Store project, Charlotte County plans for additional widening to six lanes, right-of-way acquisitions, providing updates to the committee on the project, examples of past projects, Lee County control of Burnt Store project, example of fire station, and examining demand and justification for left turn at Burnt Store Marina.

#### Agenda Item #8 - LeeTran Bus Stop and Facilities ADA Assessment Plan

Mr. Gogoi provided the presentation given by Ms. Amanda Harig with Benesch, LeeTran's consultant for the ADA Assessment Plan, at the earlier Technical Advisory Committee meeting on this agenda item for the LeeTran Bus Stop and Facilities ADA Assessment Plan. He reviewed the Power Point presentation that included slides with information on ADA purpose, study purpose, study objectives, minimum ADA bus stop requirements, signage requirements, photo examples of bus stops, transit facilities, data collection, weighting and prioritization, results, costs, implementation plan, and conclusion. The staff report with the proposed amendments was attached to the agenda packet and posted to the MPO website. He reviewed the amendments, maps, and tables included in the staff report. He said the item would come back for approval in January adding the release of the draft Work Program would assist in matching items up. The committee discussed development along the SR 82 corridor, advancement of development outpacing roadway construction, Alico extension project, future meeting presentation on the Lee County project timeline extensions as presented to the Board of County Commissioners, and public access to roads in Kingston development.

#### Agenda Item #10 - 2021 Lee County NHS Pavement and Bridge Condition Performance Data

Mr. Ron Gogoi presented this agenda item on the 2021 Lee County NHS Pavement and Bridge Condition Performance Data. The staff report with the NHS performance data was attached to the agenda packet and posted to the MPO website. He provided a Power Point presentation that included information on Lee MPO statewide pavement and bridge condition performance targets and Lee County pavement conditions. The committee discussed the development in the Babcock Ranch area, changing classification of SR 31, example of SR 82 classification changes, determination of condition of roadways by FDOT, frequency of roadway condition review, process to determine resurfacing condition and needs, types of FDOT inspected roadways, weight of vehicles, and new targets released in the coming year. 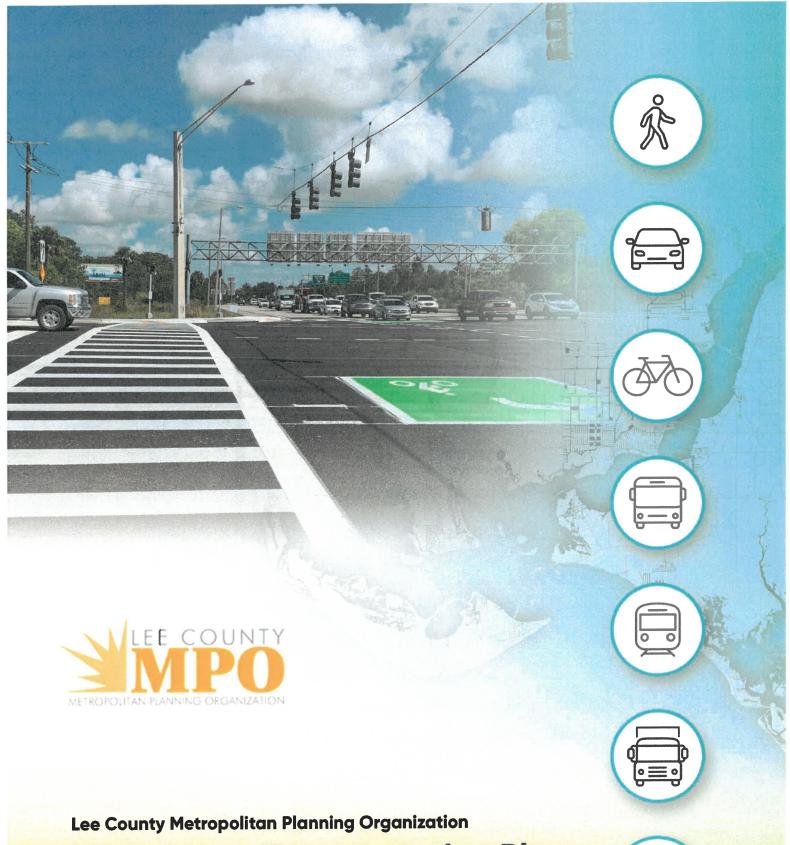
# REVIEW AND APPROVE THE PROPOSED 2045 LONG RANGE TRANSPORTATION PLAN AMENDMENTS

**RECOMMENDED ACTION:** Review and approve the proposed amendments to the

2045 Long Range Transportation Plan (LRTP).

The MPO staff is proposing LRTP amendments/modifications to be voted on by the Board at their January 20<sup>th</sup> meeting. The proposed amendments to the Needs and Cost Feasible Plan tables and maps are attached in underline and strike through format. The proposed amendments to be considered are listed below:

- Amend the Lee County project list to add the 2 to 4 lanes widening of Corkscrew Road from east of Verdana Village to the new Kingston Ranch Road in the 2031-2035 time frame to address the recently approved Kingston Ranch Development.
- Amend the privately funded project list to add in the new 4 lane Kingston Ranch Road from Corkscrew Road north to SR 82 across from Eisenhower Blvd in Lehigh Acres. The project is added to the 2026-2030 time frame and is being funded by the developer.
- Amend the Lee County project list to add in the widening of Corkscrew Road from 4 to 6 lanes from east of Fire House Lane to Alico Road in the 2036-2045 time frame.
- Amend the Lee County project list to add in the new two lane roadway extension of Sunshine Boulevard from 75<sup>th</sup> Street to SR 80 in the Cost Feasible Plan in the 2036-2045 time frame.
- Amend the State and Federal funding project list to add in a project line for the Cape Coral Bridge Reconstruction Project to match the federal funding eligibility from potential discretionary funding sources (the funding for this project is shown under the Lee County project list).
- Amend the State and Federal funding project list to add in a PD&E study for the I-75/Daniels Rest Area in the 2021-2025 time frame that will be funded with carbon reduction funding. The study will look at adding up to 150 truck parking spaces to the facility.
- Amend the Cape Coral project list to add in a PD&E study for SR 78 from Burnt Store Road to 24<sup>th</sup> Avenue in the 2021-2025 time frame to match the funding that they have included in their current year budget.
- Add in language to the Cost Feasible Plan chapter to address the type of projects that can funded with the new carbon reduction funding that is included in the new federal transportation bill.
- Add in a new combined total roadway and transit project cost table compared with revenues to illustrate the overall funding program.

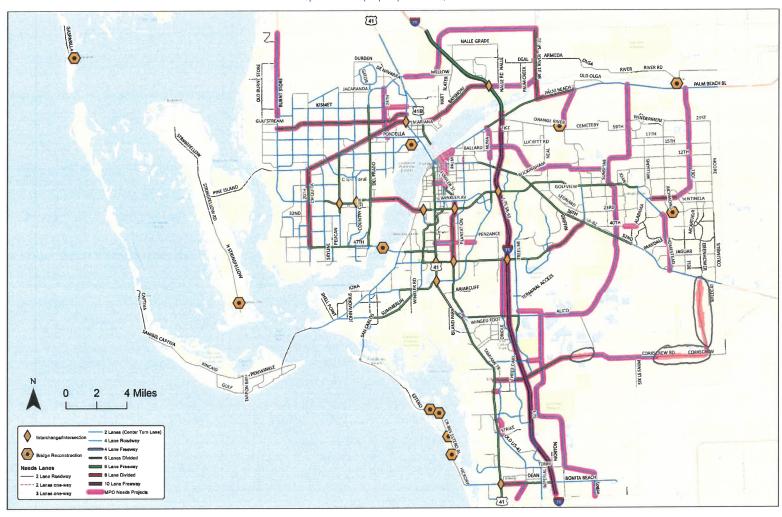

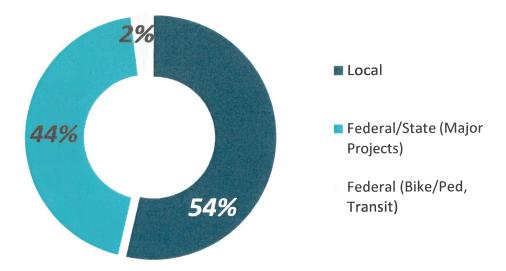

### 5.1.1 Funding Programs and Sources

The 2045 LRTP includes revenue projections from federal, State, and local sources used to develop the 2045 Cost Feasible Plan. Estimates of federal and State revenues were developed in coordination with FDOT. This revenue forecast includes estimates of available 2045 revenues for certain capacity programs for MPO planning activities. The estimated revenues can be used to fund planned capacity improvements to major elements of the transportation system (e.g., highways, transit). These metropolitan estimates are grouped into 5-year periods and one final 10-year period.

In addition to the state and federal estimates provided by FDOT, local revenue estimates were also developed in cooperation with Lee County, LeeTran and the MPO's municipal partners. **Table 5-2** presents a summary of the total projected transportation revenues anticipated to be available through 2045.

### 5.1.2 <u>Carbon Reduction Program (CRP)</u>

The CRP is a new program that is included in the recent federal transportation bill (IIJA). The FDOT and the MPO's are receiving CRP funding over the next five years to reduce transportation emissions from on-road highway sources. Project priorities are being developed that consider potential carbon reduction benefits that are consistent with guidance that is being provided by FDOT and Federal Highway. Examples of the types of projects include public transportation, complete streets, trails and nonmotorized transportation, bicycle and pedestrian facilities, deployment of ITS; traffic monitoring, management, and control programs; roundabouts; truck parking projects, replacement of street lighting and traffic control devices with energy efficient alternatives and deployment of alternative fuel infrastructure. All of the bicycle pedestrian projects in this Plan and the projects included in the TSM&O Master Plan that are consistent with the examples above are the projects that the MPO is currently prioritizing for this funding source.

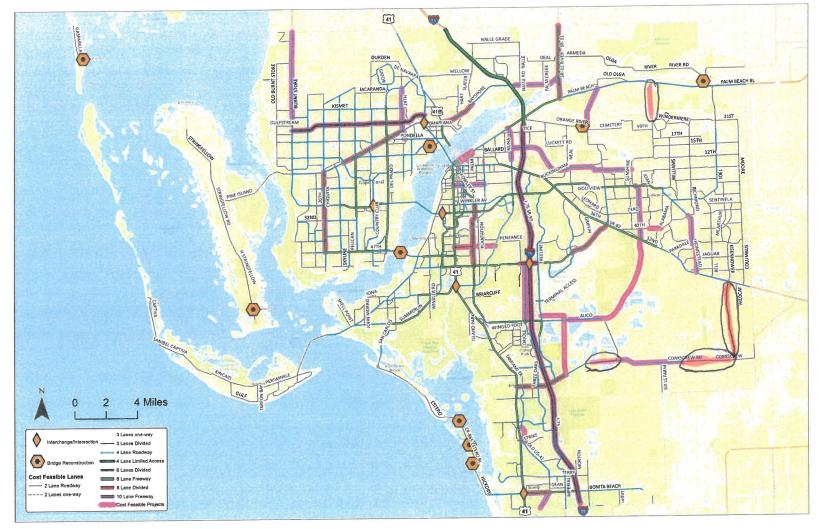












Map 5-2: 2045 Cost Feasible Roadway Projects

# REVIEW AND APPROVAL OF THE SCOPE OF SERVICES FOR THE DEVELOPMENT OF THE 2050 SOCIO-ECONOMIC DATA

**RECOMMENDED ACTION:** Review and approve the scope of services for the

development of the socio-economic data that will

be used in the update of the Regional Transportation Model (attached).

The draft scope of services for the development of the 2050 socio-economic data that will be used in the update of FDOT's Regional Transportation Model is attached for review and approval.

# SCOPE OF SERVICES FOR THE DEVELOPMENT OF THE 2050 SOCIO-ECONOMIC DATA

Socio-economic data shall be developed for the 2050 Long Range Transportation Plan (LRTP) Update by the Consultant by five year increments from 2025 to the horizon year of 2050. The Consultant shall forecast and deliver all zonal data by analysis zone (TAZ) for Lee County (the zonal map is attached). The data shall be consistent with the Florida Standard Urban Transportation Modeling Structure format and what was done for the 2045 zonal data submittal. The Consultant shall ensure that all data is based upon the latest and best available population, demographic, housing, land use, employment, economic and commercial demand data that is available. The future year population projections should be consistent with the Bureau of Economic Business Research (BEBR) population projections for the County.

### 1.0 Existing Data Collection

The project should begin with the collection of future zonal data that has recently been done by the MPO, local jurisdictions or local areas as part of other projects. The MPO will also provide the 2019 base year data in March of 2023 that has been validated by FDOT's consultant. This task will also include collecting the latest demographic, housing, land use, employment, economic and population projections since the hurricane from required and/or accurate sources.

### 2.0 Develop Zonal Data

- A. The Consultant will develop the following residential and hotel/motel data by zone for five year time frame increments from 2025 to 2050 (ZData1):
  - 1. Number of single and multi-family units
  - 2. Population by single and multi-family units
  - 3. Percent seasonal and vacant units for single and multi-family units
  - 4. Percent vehicles (zero, one and two or more) for single and multi-family units
  - 5. Number of hotel/motel rooms
  - 6. Population of hotel/motel rooms and percent occupied
- B. The Consultant will develop employment data by zone for each of the five year time frame increments (ZData2):
  - 1. Number of industrial, commercial and service employees by zone
  - 2. School enrollment by zone
- C. The Consultant will develop special generator data that includes the airport, universities/colleges, regional shopping malls and beaches (ZData3).

#### 3.0 Coordination and Data Review

The MPO in consultation with the Consultant will work with representatives from each of the local jurisdictions to help provide input into the update and development of the 2050 data and to review the draft data. The Consultant will also coordinate with local developers to get input on future development plans and timing that will help build the updated zonal data. A draft excel file of the zonal data will be provided for review and comment by the MPO staff, FDOT and the local jurisdictions prior to final submittal to FDOT's Regional Modeling consultant.

#### 4.0 Presentations

The Consultant with assistance by MPO staff will make up to three presentations to the MPO committees near the end of the project to provide an overview of the process and results

#### 5.0 Schedule

This project will be completed within one year of Notice to Proceed issued by the MPO.

# RECOMMEND MPO SUPPORT OF FDOT'S NEW BRIDGE, PAVEMENT AND SYSTEM PERFORMANCE TARGETS

**RECOMMENDED ACTION:** Recommend that MPO Support FDOT's Statewide

PM2 and PM3 Targets for the Second Performance

Period

Back in September 2018, the Lee MPO agreed to support FDOT's statewide pavement and bridge performance targets (PM2) instead of establishing targets of its own. By doing so, the MPO agreed to plan and program projects in the TIP that once implemented, were anticipated to make progress towards achieving the statewide targets. Likewise, the MPO also agreed to support FDOT's statewide system performance (PM3) targets. The 2 year targets for this First Performance Period reflected the anticipated performance levels at the end of Calendar Year (CY) 2019 while the 4 year targets reflected anticipated performance level at the end of CY 2021.

With the conclusion of the First Performance Period (January 1, 2018 through Dec 31, 2021), FDOT has now set 2 and 4 year statewide targets for the Second Performance Period (January 1, 2023 through Dec 31, 2025) for PM2 and PM3 as shown in **Attachment A**. These targets reflect anticipated performance levels at the end of CY 2023 and at end of CY 2025 respectively.

The establishment of PM2 and PM3 targets for the Second Performance Period by FDOT will require Lee MPO to support the targets as they did for the First Performance Period. Accordingly, the TAC and CAC will be asked at their January 5<sup>th</sup> meetings to recommend that the MPO Board support the statewide targets for the Second Performance Period.

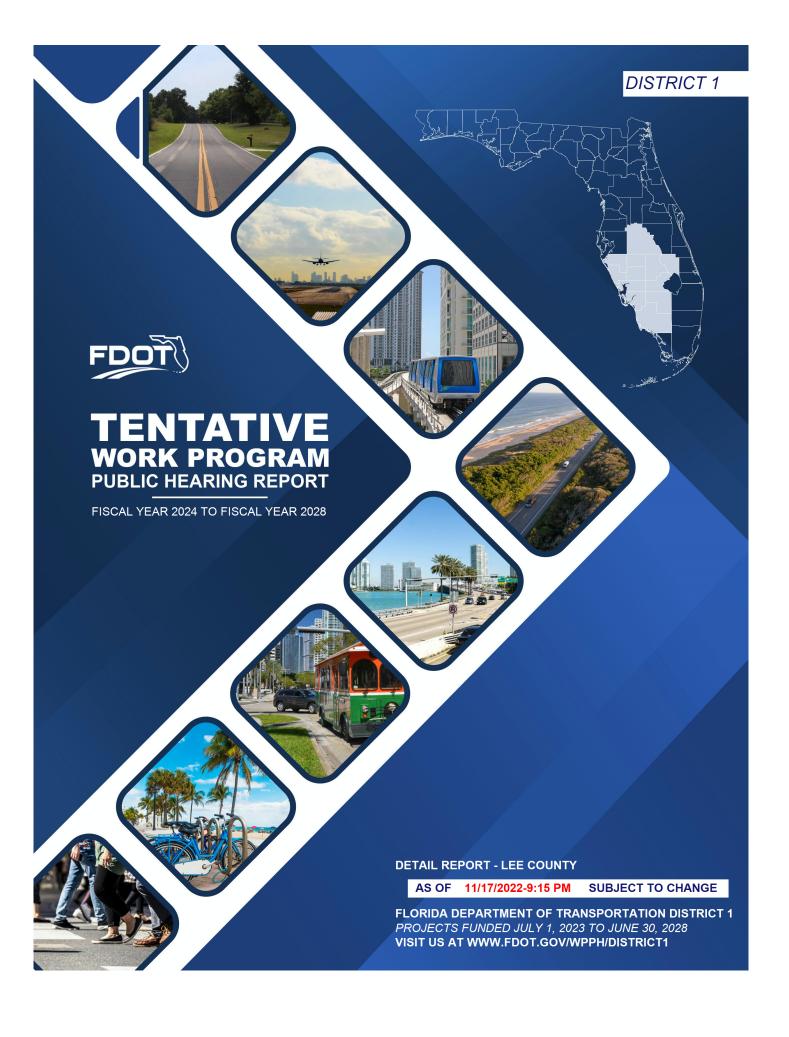
