### LeeTran In a few words



- Mission: Driving patrons safely, timely and efficiently to and from their destination
- Vision: To be an elite commuter service system that provides excellent customer service, on-time arrivals and departures, and superior safety measures
- Passport provides more than 140,000 Paratransit trips per year in Lee County

### Demand Response as a Service

- Demand Response also known as Paratransit is a door-to-door service
- This service is provided as complementary service to mirror the Fixed Route service
- Provides access to public transportation to individuals with a physical, mental, or visual disability preventing them from transporting themselves
- To be protected by the ADA, one must have a disability, which is defined by the ADA as a physical or mental impairment that substantially limits one or more major life activities



### Pick-up Window & Trip Planning

- Passport has a one hour pick up window for trips within city limits
  - Ft. Myers to Ft Myers, Cape Coral to Cape Coral or Lehigh to Lehigh
- Passport has a one hour and a half for trips crossing city limits
  - Cape Coral to Ft. Myers, Cape Coral to Lehigh, Cape Coral to Bonita Springs
- Book trips up to 1 week in advance
  - Paratransit/ADA a minimum of 24 hours prior to trip
  - TD a minimum of 48 hours prior to trip
- Cancel all trips with enough notice
  - minimum 2 hours prior to the scheduled pick-up time



#### Paratransit/ADA

- Applicants must reside within corridor (3/4 of a mile of Fixed Route service)
  - Trips must originate and end within corridor
  - A corridor of travel is established based on the published bus schedule and routes
- Must meet eligibility requirements: individual with a disability, and the transportation disadvantaged
  - · Eligibility could be temporary, conditional, or unconditional
- Requires a \$3.00 co-payment
- Fare can be purchase at LeeTran Headquarters, The Rosa Parks Intermodal Center, or via phone by contacting customer service

## Transportation Disadvantaged

# Commission for the Transportation Disadvantaged Trust Fund Eligibility Criteria

- Transportation Disadvantaged is for those persons who because of a physical or mental disability, income status, or age are unable to transport themselves or to purchase transportation, or children who are handicapped or high-risk or at-risk.
- Household income must meet a maximum of 150% of the current Federal Poverty Guidelines.



# Transportation Disadvantaged

- Eligibility: Individuals live outside of the corridor
  - Low income/socioeconomically disadvantaged
    - Income based
  - Transportation Disadvantaged
    - Cannot access public transit
    - No other means of transportation available
  - 60 years or older
  - Disability
  - At-risk youth
- Cost \$3.00 (co-pay)



## Transportation Disadvantaged

Proof of Household Income is **Required** for all Transportation Disadvantaged Applicants. Acceptable types of proof of income are:

- Current tax return
- Unemployment Compensation Income Verification
- Child support letter
- Social Security Income Letter (SSA, SSI, SSDI)
- Minimum of two (2) employer pay stubs from the past two months
- Retirement/Pension Statement (includes VA)
  - Self-declaration of income is not accepted.

#### Med-Waiver

- Trips are funded via Med-Waiver program
- Follow ADA eligibility criteria
- Service authorization required with approved med-waiver sites
- No co-payment
- Med-waiver trips are subject to longer onboard travel time due to group trips
