Petition opposing the bike trail by San Carlos Park, and
Petition opposing the bike trail by the Granada Lakes community.

Please also include the following comments in all MPO member packets in preparation for this meeting.

In reviewing the latest information from your planner, Volkert, it appears that your planner has now added what is described as Snoqualmie gates for the golf cart crossings at the Vines in Estero. Now, after totally omitting the Vines and Estero Country Club from the planning map, they are making a futile effort to convince the MPO that a public golf course in the State of Washington has a relation to having a bike path running through a secure, gated golf course community in Lee County, Florida.

Those new gates and fencing only highlight further the inappropriateness of having a bike path come through the middle of this golf course. Not only would these gates as depicted create havoc in the use of the golf course, but whenever they open up the gates it would allow migration of bikers and walkers into our otherwise secure, guarded community.

Again, I stress that we asked Ned Baier if there was another gated golf course community in the USA that has a bike path bisecting it. While he promised they were researching it, the only one he has found to date is this public course in Snoqualmie Washington which has no houses along the course or the path. Still, Volker has

presented not one gated golf course community with such a path and certainly not one path through a gated golf course community in the State of Florida.

Separate and apart from the negative impacts upon the Vines and Estero Country Club, the report as presented totally ignores the intrusions in the backyards of the adjacent San Carlos Park neighborhood and the otherwise isolated community at Granada Lakes near Alico Blvd. The bike path as proposed would run right through the backyards of private homeowners in San Carlos Park and would destroy the views and privacy of the homes in Granada Lakes while also allowing invasion of their clubhouse and bathroom facilities. Neither of these communities and the negative effects upon them are addressed in the planning report that is being shoved through for acceptance by the MPO.

Moreover, since the planner's maps did not show the Vines on the map, and certainly no one at Granada Lakes is indicated, none of these adjacent communities were aware of this bike path until just recently. It is these most directly affected communities whose opinions should be the most sensitively considered. It is their lives and quality of lives, as well as the enjoyment of the homes they purchased that are being detrimented.

There are viable alternatives to coming through the Vines, San Carlos Park, and Granada Lakes, and that alternate path can be made safe for all bikers to use. The MPO should be considering how to make the path work for everyone, but especially to those whom are most negatively affected by this proposed plan.

BONITA ESTERO RAIL **TRAIL FEASIBILITY STUDY**

Presentation to the Lee County Metropolitan Planning Organization

INTRODUCTION

Good morning. My name is Charles Thomas. I am a professional planner with more than fifty (50) years of public and private sector experience in planning and zoning. I have been accepted as an expert before multiple jurisdictions and courts. I am before you today on behalf of the Vines Community Association and the Estero County Club, Inc. The following comments will focus upon the segment of the proposed Rail Trail between Estero Boulevard and Alico Road including residential areas in San Carlos Park and Granada Lakes as well and the Vines/Estero Country Club community.

I will present my comments for 3 minutes and the balance of my comments and concluding remarks will be presented by others.

The Bonita Estero Rail Trail Feasibility Study is before you today for acceptance. Although the Study area extends from Alico Road on the north to Bonita Beach Road on the south, our focus is upon the segment between Alico Road and Estero Parkway. As you know, the Vines and the Estero Country Club are within a gated community bisected by the Seminole Gulf Railway right-of-way and thus by the proposed Rail Trail. Following a review of the Feasibility Study, the Bicycle and Pedestrian plans adopted by the Village of Estero, the City of Bonita Springs, Lee County, Collier County and by the Lee County MPO, and field observations, it is my opinion that the Feasibility Study does not adequately identify and address issues of functionality, safety, security, easy trespass emergency access, maintenance and operation that impact the Vines/Estero Country Club community and the San Carlos Park and Granada Lakes communities to the north.

The Vines/Estero Country Club community, the residential areas immediately to the north, consisting of single family homes whose yards directly abut the Railway corridor and the Granada Lakes community will each be affected by issues of noise safety, security, easy trespass, maintenance and operation the Rail Bike Trail. In addition, proposed Rail Bike Trail would expose the Granada Lakes community to disruption, and potential obstruction of its sole access from Alico Road.

Therefore, it is my professional opinion that, although it may qualify for FDOT Sun Trail funding, the unique conditions presented by bisecting a gated community, concerns regarding safety, security, impediments to emergency access, and limitations upon accessibility and connectivity render the segment between Estero Parkway and Alico Road inappropriate for inclusion in the Bonita Estero Rail Trail.

ISSUES & CONCERNS

Safety and Security: The Seminole Golf Railway crosses the Estero Country Club's cart path and its sole access roadway Vintage Trace Circle, multiple roadway crossings within the San Carlos Park residential area, and the sole access to Granada Lakes. Each of these crossings will expose pedestrians and bicyclists to conflicts with vehicle traffic, and will require signage, signalization and, in areas of high vehicle volumes will require grade separation by means of a bridge or tunnel. Measures to assure the safety and security of pedestrians and bicyclists will be necessary throughout the length of the corridor; the Feasibility Study identifies the need to "achieve a reasonable level of safety and security...", but identifies only Crime Prevention Through Environmental Design (CPTED) utilizing Natural Surveillance, Natural Access Control and Territorial Reinforcement, Trail Ambassador and Trail Watch Programs as preventative measures. These measures provide little assurance to either users or abutting property owners that adequate safety and security will be provided.

The Feasibility Study recognizes that there are unique issues presented by the passage through the center of a gated golf course community and identifies the need for "Specific Mitigation Strategies for Trail Impact on Neighboring Golf Course and Gated Communities". The Study identifies a need to buffer "any trail located within a 180-degree arc of tee orientation and within 200 yards or less in distance" or within 50 feet of a fairway or the backside of a green by "berms, trees and/or shrubs". The Feasibility Study provides examples of fencing, vegetation, signage, netting and chain link cages that could be utilized to protect trail users from proximity to a golf course. The presentation presented to you today presents an example "of the use of security features on a trail next to a golf course" consisting of gates where the corridor enters the golf course property and fencing and netting along the perimeter of the golf course property. In addition to assuring safety and security, implementation of these measures would require careful selection of design solutions and the assignment of the cost of implementation and maintenance to the Rail Trail.

However, none of the above measures address the safety and security of the residents and golfers with a gated community that is bisected by an active trail corridor. The presentation before you today recognizes the presence of the golf cart crossing as integral to the golf course and postulates "Golf Crossing Gated Access" as the resolution to conflict between the existing golf course and the proposed Rail Trail. It also fails to recognize the crossing of Vintage Trace Circle, a roadway that is internal to the gated community and is the only

roadway providing access, including access for emergency vehicles, and egress to their homes for nearly 300 property owners.

Connectivity: The study area extends from Alico Road on the north to Bonita Beach Road on the south. The width and volume of traffic of Alico Road and the oblique angle at which the Railway crosses Alico Road present significant obstacles to connectivity with the Railway further to the north and thus to the integration of the Bonita Estero Rail Trail into a regional Rail Trail; signalization or grade separation will be required to achieve this connection. Although the Railway crosses Bonita Beach Road and extends into Collier County, the proposed Rail Trail terminates at Bonita Beach Road. At both the north or south ends of this study area, connection to a regional network may be achieved only through on-road facilities.

The Village of Estero's CIP Project Summary for the "SUN Trail North" describes the Sun Trail project as: "The construction of an off-roadway multi-use pathway on the existing Seminole Gulf Railway right of way from the Village's southern limits to Estero Parkway. The Village's CIP also contemplates improvements including a 7-ft. buffered bike lane and sidewalks along both sides of the road to provide continuous bicycle and pedestrian facilities between US41 and Three Oaks Parkway. These improvements will provide connectivity between a northern terminus of the Rail Trail at Estero Parkway to an extensive bicycle and pedestrian network providing bicyclists with a loop utilizing the Rail Trail, Estero Boulevard, Three Oaks Parkway and Bonita Beach Road.

Accessibility:

The Feasibility Study does not address accessibility of the Rail Trail by potential users. With the exception of the park in Old Bonita Springs, the Railway corridor does not abut or connect with a park or other facility where parking, restrooms, shelter or other facilities are (or would be) provided. The Feasibility Study does not address the need for such facilities, particularly at the north end of the corridor where the Rail Trail would effectively dead-end at either Estero Boulevard or Alico Road. It will be necessary to provide such facilities at the northern terminus of the Rail Trail to provide access for recreational users and users having limited mobility. The Estero on the River Park can provide these facilities and function as a northern terminus for trail users much as the park in Old Bonita Springs provides a southern terminus.

CONCLUSION

Although we understand, and share the affinity for the preservation and potential use of linear corridors such as that provided by the Seminole Gulf Railway right-of-way, it is my professional opinion that safety and security concerns, the concentration of conflicts within of the Vines/ECC community, the proximity of residential development to the boundaries of the corridor in the area immediately north of the Vines/ECC community in San Carlos Park, the conflict with access to the Granada Lakes community and the potential impediments to and cost of a grade separated connection crossing Alico Road support the conclusion that the Alico Road to Estero Boulevard segment of the Seminole Gulf Railway right-of-way is inappropriate for inclusion in the proposed Rail Trail.

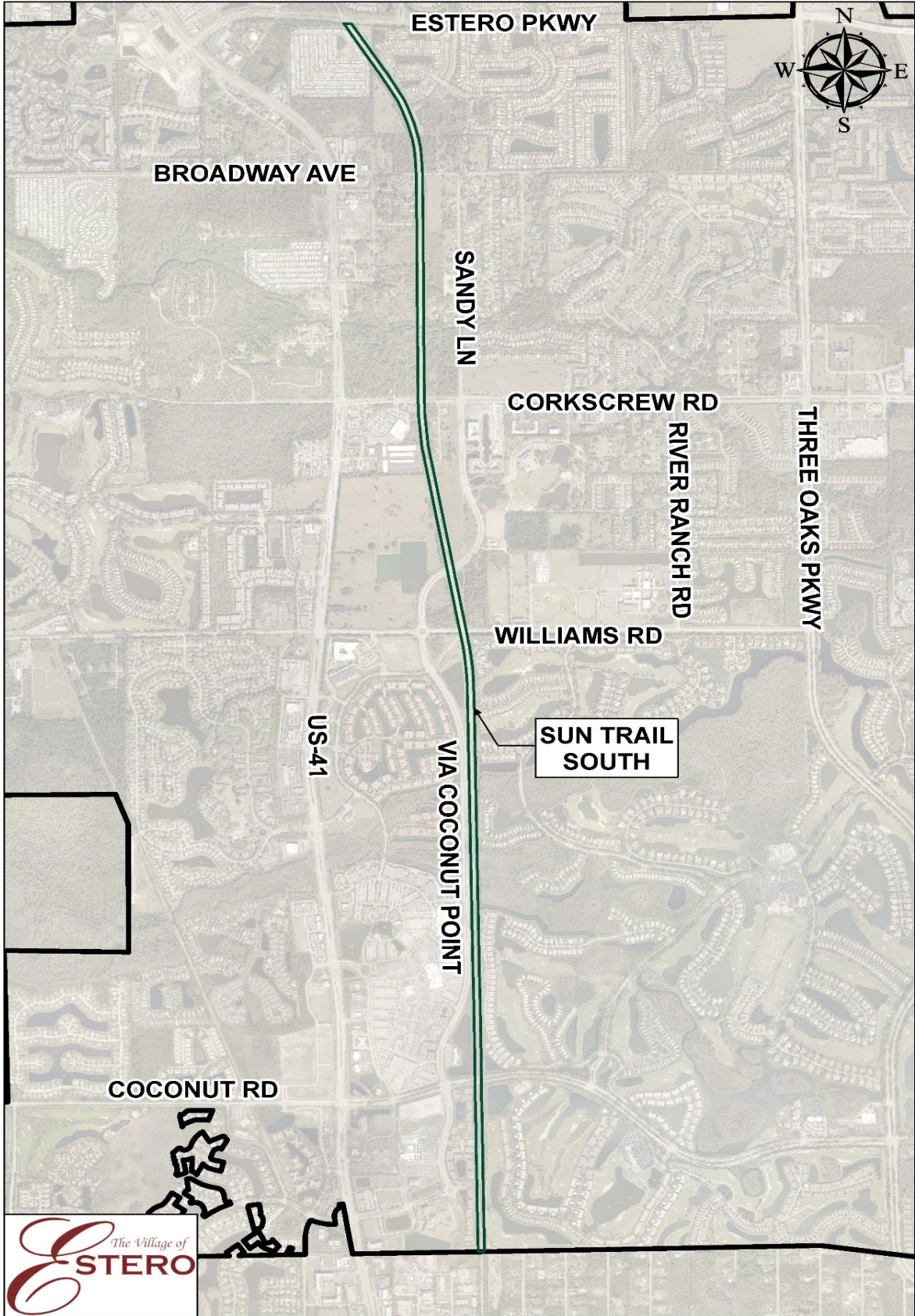
Project Justification:

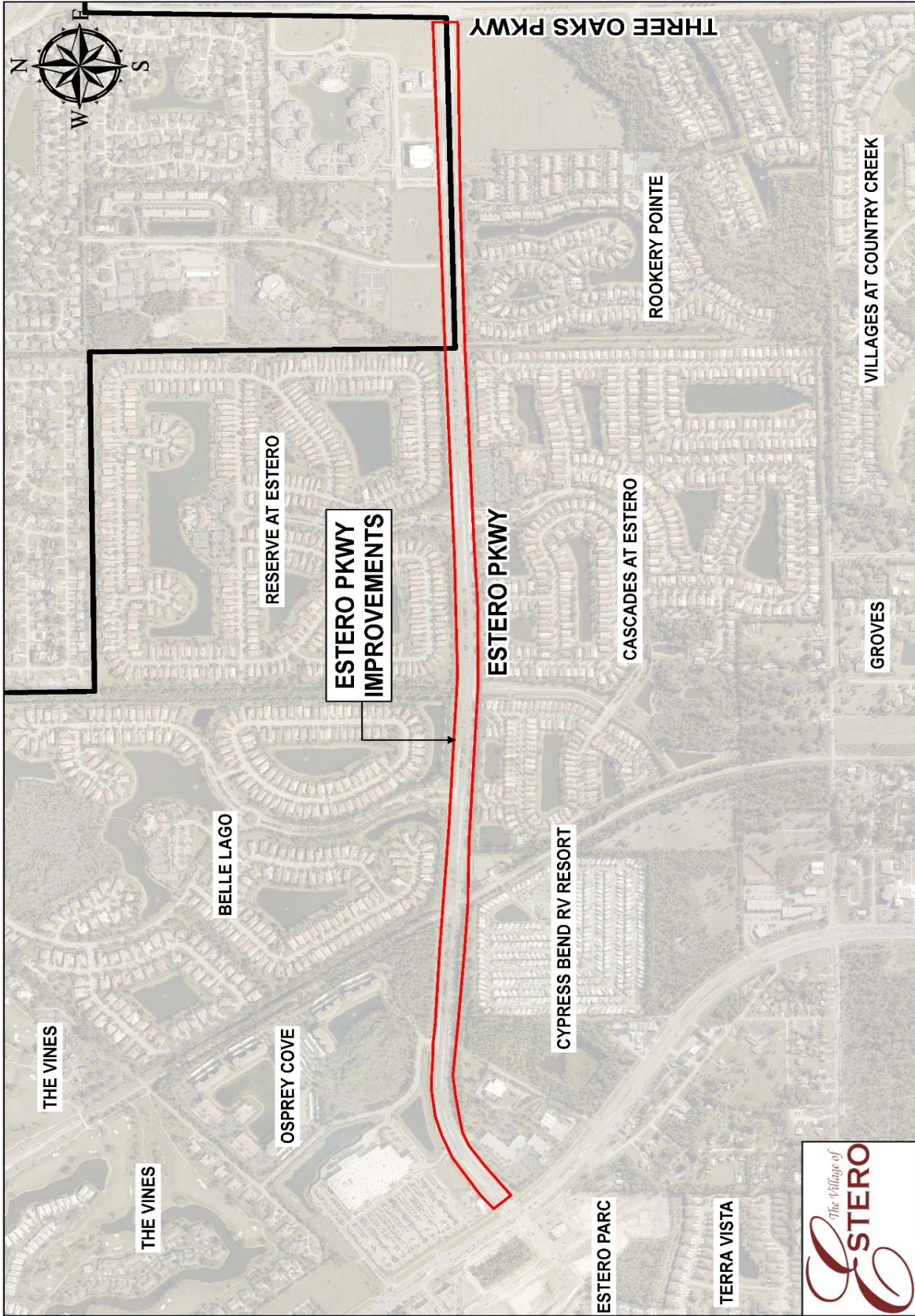

We are strongly opposed to the bicycle and walking path routes along the railroad right of way as shown in Alternatives 1 & 2.

These routes will pass through the center of our gated community, The Vines, dividing both the roadway and the golf course. Bisecting our community with this path would negate the security benefits of being a gated community and create an extreme hazard to pedestrians, cyclists and vehicles, including golf carts.

There is only one major road inside our community and the majority of homeowners, vendors and all Estero Country Club visitors must cross the railroad tracks to enter and exit the community. In addition, all golf carts cross the tracks twice during each round.

While the concept of using the railroad right of way is appealing, a route that does not bisect our community must be found to gain our support. Therefore, the only currently proposed route that we can support is Alternative 3.
