Agenda Item #3 - Public Comments on Items on the Agenda

Agenda Item #4 - *Approval of the August 12, 2020 Minutes

Agenda Item #5 - US 41 FRAME Project Update

Mr. Timothy Smith with FDOT presented this agenda item as an update on the US 41 Frame project. He provided a Power Point presentation that included slides with information on project details, goals, proposed locations, current status, plans development, project approach, deployment considerations, types of CV applications, available CV applications, pedestrian protection programs, next steps, and potential benefits of connected vehicles. Mr. Smith asked if there were any questions. Mr. Gogoi thanked Mr. Smith for his presentation.

Agenda Item #6 - Intersection Improvement Update

Mr. Steve Jansen presented this agenda item as an update on new signalized intersections in Lee County and proposed improvements to existing intersections. Mr. Jansen gave a Power Point presentation that included slides with information on new improvements for 2021 with map, new signalized intersections under contract with map, new signalized intersections in design with map, and new signalized intersections by developers. The committee briefly discussed possible plans to extend Nalle Grade Road to SR 31, plans to convert flashing signal at SR 78 and Nalle Road to functional signal, warrant study for that intersection, construction cost for Gateway roundabout, and striping on Ortiz roundabout.

Agenda Item #7 - Metro Parkway CFI Design Concepts

Mr. Christopher Speese With FDOT presented this agenda item on Metro Parkway CFI Design Concepts. Mr. Speese provided a Power Point presentation with slides that included information on project description, existing conditions, proposed typical section, benefits of CFI, description of CFI, video of movements through CFI, pavement marking plans, through movements of bicycles, and additional video links with supplemental information. Mr. Speese asked if there were any questions. The committee discussed possible impacts to hospital entrance/access, impacts to roadway, two-stage bicycle boxes, educational programs for public related to CFI, signage, discussion at BPCC meeting regarding signage for wrong way drivers, additional ideas for signage, cyclists use of CFI, and providing LeeTran with plans when available. Mr. Stephen Alianiello with FDOT's Commute Connector presented this agenda item. Mr. Alianiello provided a presentation with information on introductions of staff, description of service program, services program provides, commuter platform, program updates, and additional commute platform insights. Mr. Gogoi asked if the data was for all of District One. Mr. Alianiello replied yes and added that he could also provide data for just Lee/Collier counties. Mr. Alianiello continued his presentation with information on the emergency ride home program. Chair Jansen asked if there were any questions. Mr. Scott mentioned the van pool data and the impacts of telecommuting. Agenda Item #10 - LeeWay Activity Update Presentation

Ms. Susan Drotleff with Lee County DOT Tolls presented this agenda item as an update on recent LeeWay activity. Ms. Drotleff gave a Power Point presentation that included slides with information on LeeWay transponder benefits, electronic toll collection, accounts receivable toll-by-plate transactions, combined monthly traffic comparison, LeeWay interoperability efforts, national interoperability efforts, and capital improvement projects. Mr. Scott asked if the transponder percentage data represented any transponder or just LeeWay transponder. Ms. Drotleff responded the data was for all transponders. A brief discussion followed on SunPass, E-ZPass, phases for converging systems, special transponders, and functionality of existing transponders. Mr. Don Scott presented this agenda item as an update to the 2045 Transportation Plan Development. He provided a Power Point presentation with slides that included information on public involvement, funding programs and sources, roadway projects, existing priority projects, cost feasible project tables, transit needs, 2045 mix of potential modes considered, transit cost feasible plan, transit costs, transit cost feasible table, bike ped facilities map, and bike ped cost feasible project list. Mr. Gogoi then reviewed several slides on RSW freight data and commodity flow analysis. Mr. Scott continued the presentation with slides on TAC/CAC changes and new Lehigh Acres schools map. Mr. Scott noted the Report will be adopted by the MPO Board at its December 18th Meeting. Mr. Scott asked if there were any questions. There were none.
