Agenda Item #3 - Public Comments on Items on the Agenda

There were no public comments on items on the agenda.

Agenda Item #4 – Approval of March 9, 2022 Meeting Minutes

Mr. Mike Cook made the motion to approve the March 9, 2022 Meeting Minutes. Mr. Scott Philips seconded the motion. There were no objections, and the motion passed unanimously.

Agenda Item #5 - LCDOT Project Update

Ms. Jillian Schiller with Lee County Department of Transportation (LCDOT) provided a Power Point presentation that included slides with information on the Lee County Advanced Traffic Management System (ATMS) Phase III, Lee County ATMS history, overview of Phase III, signalized intersection upgrades, signalized intersection list, closed caption television (CCTV) cameras, CCTV camera list, arterial dynamic message signs, fiberoptic communication, and cost estimate. The presentation slides may be viewed here: <u>ATMS Presentation</u> The committee briefly discussed type of project, funding, capacity of county to manage project, technology upgrades, goal of CCTV cameras, data collection from CCTV, height requirements for detection cameras, integrating with dispatch system of emergency

management for signal preemption, and fiberoptic network. Ms. Schiller also presented information on findings/solutions to westbound traffic backups caused by left turn queues at the Daniels/Treeline Intersection. The committee discussed U-turn movements in the area, possible signage to indicate U-turns, U-turns near Corkscrew on Ben Hill Griffin, long term projects that will ease traffic at Daniels/Treeline intersection, origin and destination of trips, difficulty with extending left turn lane considering lack of right-of-way, funding constraints, prioritization and funding considerations for other projects across Lee County, FDOT maintenance and control of roadway at Daniels/Treeline, traffic backups across Lee County, inflation and project cost increases, and in-house design cost savings.

Agenda Item #6 - Traffic Crash Associated Medical Costs at Trauma Center

Ms. Syndi Bultman with Lee Health Trauma Services provided a Power Point presentation that included slides with information on Lee Health Trauma Center mission and vision, difference between emergency department and trauma center, trauma system definition, national traffic crash data, national key findings, Dangerous by Design 2021, comparison of counites of injury, injury admissions for current fiscal year, MPO sourced data on injuries and fatalities, injuries and fatalities related to drinking/distracted/drugs, historical trauma data, red light/failure to yield data, Florida crash related cost estimates, and national data. Her presentation can be viewed here: Lee Health Presentation The committee discussed the age range of those involved in crashes, differences between Collier County versus Lee County, seasonal differences with regard to traffic/crashes, vehicle miles travelled impact, motorcycle crashes, influence of alcohol on crashes, need for all road users to be attentive, example of other countries in Europe, involvement of law enforcement, example of other state, increasing penalties, involvement of legislation, use of data, road design, education, MPO grant to use public service announcements from local high school students, and new Dangerous by Design report.

Agenda Item #7 - Hurricane Evacuation Challenges

Ms. Sandra Tapfumaneyi with Lee County Division of Public Safety Emergency Management Program provided a Power Point presentation on Hurricane Evacuation Challenges. Her slides covered hurricane/tropical storm frequency data, evacuation authority information, planning for evacuations, elements of evacuation planning, southwest Florida evacuations, reasons for evacuations, examples of past hurricane storm surges, Hurricane Irma facts, evacuation zones in Lee County, LeeTran emergency evacuation bus routes, state/regional evacuation studies, evacuation decision making tools, southwest Florida (SWFL) regional evacuation guide, and notification and alert systems. Her presentation can be viewed here: Evacuation Presentation The committee discussed possible changes to evacuation zones, electric vehicle considerations for evacuation, lack of gas during evacuations, and storm surge after Irma.

Agenda Item #8 - Safe Streets for All Discretionary Grant Opportunity Update

Mr. Don Scott provided an update on the Safe Streets for All (SS4A) Discretionary Grant Opportunity Program. The Power Point presentation included slides with information on the SS4A program, eligibility, funding, definition of comprehensive safety action plan, action plan process, application choice pathway, examples of supplemental action plan activities, implementation grants, legislative selection considerations, joint applications, and unique entity identifiers. His entire presentation can be accessed here: <u>SS4A Presentation</u> The committee discussed submission, performance measures, time frames, data driven grant application process, application deadline, high crash corridors, input from FDOT Safety Office, and local funding match.

Ms. Victoria Peters introduced Mr. Gordon Mullen with RK&K, FDOT's consultant for the Old US 41 PD&E Study project, to present this agenda item. Mr. Mullen presentation included slides with

information on project phases, safety message, project goals/need, alternatives, new quadrant roadway, new traffic signals, U-turn pavement bulb outs, major intersections, evaluation matrix, project timeline, public workshop, comment topics, next steps, and contact information. LEE COUNTY PORT AUTHORITY PRESENTATION

At the September 14th TMOC meeting, TMOC member and Airport Planner Ian Sikonia will provide a presentation on the latest Lee County Port Authority activities. The presentation may cover ongoing and upcoming air side and landside projects, update commercial developments in airport properties, airport growth covering RSW and Page Field Airports, latest enplanement numbers in RSW and how they now stack up against 2019 and 2020 numbers.

RECOMMENDATION FROM RSA CONDUCTED ON SAN CARLOS BOULEVARD FROM LINDA LOMA TO KELLY ROAD

FDOT's Adopted Work Program (WP) and the Lee MPO's Transportation Improvement Program (TIP) includes a median modification safety project on San Carlos Boulevard from Linda Loma Drive to Kelly Road. The design phase is underway and the construction phase is funded in FY 2025. As a precursor to this project FDOT completed a Road Safety Audit (RSA) of this segment and has come up with recommendations that will be implemented during construction of the median modification project. District 1 Safety Administrator Keith Robbins and other members of the FDOT Safety Office will be at the meeting to present the RSA recommendations.

ANALYSIS OF HIGH CRASH CORRIDORS IN LEE COUNTY

District 1 Safety Administrator Keith Robbins and other members of the FDOT Safety Office will be at the September 14th TMOC meeting to present the top high crash corridors in Lee County. The presentation will cover the following topics:

- Highway corridors and intersections in Lee County with the highest number of fatalities and severe injuries
 - Provide crash data (fatalities and severe injuries) for those corridors/intersections by either emphasis areas, or simply by all crashes, pedestrian and bicyclist crashes.
- Any persistent factor(s) at those locations that the analysis may have unearthed as contributing causes for the severe crashes (is it because of high risk road features or structural issues in the pavement, lack of specific safety needs of road users, etc.).
- Any planned or funded push button improvements (that are not in the Adopted Work Program) to address safety in any of those corridors, and/or new safety projects that are being considered in the Draft Tentative Work Program (FY 2024 – FY 2028).
- Recent changes in the Florida Design Manual that may change the way FDOT undertakes safety projects.

VILLAGE OF ESTERO PROJECT UPDATE

The Village of Estero has successfully applied for legislative earmarks this fiscal year involving two projects that are some of the highest priorities for the community. They include the Sandy Lane and Broadway East Bike/Ped Improvements and Estero on the River. TMOC member and Village Public Works Director David Willems will provide a presentation at the September 14th TMOC meeting.

CARBON REDUCTION PROGRAM PRIORITIES

INFORMATION ITEM:

The Bipartisan Infrastructure Law (BIL) established the Carbon Reduction Program (CRP) which provides funds for projects designed to reduce transportation emissions, defined as CO2 emissions from on-road highway sources. A portion of the total funds apportioned to a state are suballocated to urbanized areas with populations greater than 200,000 and urbanized areas with population 50,000 to 200,000.

For FY 2022, the suballocation of CRP funds for the Cape Coral urbanized area is \$1,128,685. The FY 2022 funds will most likely be available for programming projects in FY 2024, the first year of FDOT's new Work Program for the period covering FY 2024 through FY 2028. Funds may be also available for programming projects in the subsequent years of this work program which is currently under development.

Eligible projects for CRP funds include bicycle pedestrian facilities, micromobility, public transportation, congestion management technologies, etc. and they must be identified in an MPO's Transportation Plan. That makes most of the bicycle pedestrian projects in the Lee MPO's Adopted Multimodal Box Fund Priorities eligible for CRP funds. The recommended priorities (shown in **Attachment A)** have been recommended for MPO Board approval by both the MPO's Technical Advisory Committee and the Citizen Advisory Committee. Priorities have been assigned consistent with their priority order from the adopted Multimodal Box Fund Priority list.

PROJECT OVERVIEW

FDOT, District One, is designing improvements to SR 739 from the Caloosahatchee River to north of SR 78 in Lee County. The project was requested by the FDOT District One Traffic Safety Department and is intended to improve safety, enhance traffic flow, and reduce crashes.

The project consists of milling and resurfacing of the roadway as well as constructing a continuous raised median with bi-directional and full median openings. Two pedestrian hybrid beacons will be provided south of Pondella Road and at Mariana Avenue. Additional improvements include upgrading the traffic signal at Pondella Road; providing upgrades in accordance with the Americans with Disabilities Act (ADA); and lighting, signing and pavement markings, and drainage improvements.

This meeting is being held to present project information and provide an opportunity for the public to offer feedback. FDOT will accept written comments during and after the meeting.
