### PRESENTATION OF FDOT'S VISION ZERO ACTION PLAN FOR LEE COUNTY

#### DISCUSSION:

FDOT District 1 has been working on a Vision Zero Action Plan covering the state highways in Lee County since early summer 2023. A draft Collison Profile Analysis was completed at the end of December 2023.

FDOT will provide a presentation of the work completed so far as part of this project, and next steps, at the March 13<sup>th</sup> TMOC meeting. At this meeting, an update on contract negotiations with Stantec, the consultant selected for undertaking the Lee MPO SS4A Action Plan, and the commencement of the project will also be provided.

## AI ASSISTED TRAFFIC MANAGEMENT SYSTEM PRESENTATION

#### DISCUSSION:

Rekor Systems Inc. is a global Artificial Intelligence (AI) technology company. State DOTs and local governments around the US have deployed Rekor's traffic management technology to improve incident response and overall roadway safety. According to their website, the technology involves implementation of a cloud based roadway intelligence platform which uses artificial intelligence and integrates data from multiple sources to provide more comprehensive and quicker incident identification than current methods. The technology also comes with a collision predictive software.

FDOT District 7, the City of Tampa, and Pinellas County have been using the same system and the AI platform to collaborate and manage traffic delays on their transportation network. Rekor representatives and Pinellas County Public Works staff will be at the March 13<sup>th</sup> TMOC meeting to give a presentation on how the technology and its various applications work and answer questions. With our high traffic fatality numbers in Lee County, and with D1 and Lee MPO collaborating to develop a comprehensive safety action plan for Lee County roadways, the presentation could be useful to understand what AI may have to offer to address safety needs.

# PRESENTATION ON SR 82 SAFETY IMPROVEMENTS

#### DISCUSSION:

FDOT will be working on median safety improvements on SR 82 at the intersections of Sunshine Boulevard, Alabama Road, Blackstone Road/Grant Boulevard, Rue Labeau Circle, Parkdale, Bell Boulevard and Columbus Boulevard. FDOT will be presenting proposed improvements and the project schedule at the March 13<sup>th</sup> TMOC meeting.

Virtual and in-person public meetings by FDOT are tentatively planned for 4/9/2024 and 4/11/2024 respectively.
